### A BILL FOR AN ACT

RELATING TO ENVIRONMENTAL CONSERVATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the acquisition of SECTION 1. 2 Lipoa point to protect and preserve public access, along with 3 traditional cultural gathering rights, and staving off 4 development was a monumental landmark achievement in land 5 conservation. The legislature finds that in order to protect 6 and preserve this area and ensure the public health and safety 7 of this pristine region while community planning is ongoing 8 requires support from both the State and local county government 9 as well as private and nonprofit entities. In the past, while 10 appropriations have been made to the department of land and 11 natural resources, the funds were not specifically set aside for 12 management activities. The community has instead relied on 13 private groups to fund essential maintenance activities to make 14 the area a safe place for countless visitors who travel here 15 every year and the many local families who come for surfing, 16 fishing, diving, and other recreational activities.

1 The legislature further finds that many visitors use the 2 waters of the adjacent Honolua Bay Marine Life Conservation 3 District(MLCD). Their support along with that of the county, 4 State, and community and nonprofit groups can create a dedicated 5 fund for the protection of this asset for the public. 6 Furthermore, the legislature finds that other states have 7 initiated contributions from visitors who frequent and use the 8 natural resources of their natural attractions as a way to 9 continue to beautify and preserve the area while educating 10 visitors about the use of the contributions. Most importantly, 11 visitor contributions for protecting the areas led to the 12 visitor community supporting these critical activities. The 13 fees, collected while visitors are using the natural attractions 14 are applied only to protecting these vital natural treasures. 15 By creating a special fund for a visitor contribution program 16 for individuals frequenting Honolua Bay MLCD along with other 17 private and government funding, the legislature finds that the 18 department of land and natural resources can ensure continued 19 access and enjoyment by all in addressing the basic health and 20 safety issues for Lipoa point.

1	The purpose of this Act is to establish a visitor fee for
2	passengers of maritime commercial vessels crossing through the
3	ocean waters surrounding Lipoa point, to be used for the
4	management of the Lipoa point area and educate visitors of the
5	stewardship activities being funded by the visitor fees.
6	SECTION 2. Chapter 171, Hawaii Revised Statutes, is
7	amended by adding two new sections to be appropriately
8	designated and to read as follows:
9	" <b>§171-A Lipoa point visitor fee.</b> (a) The department may
10	impose a visitor fee of \$1 to each paying passenger of a
11	maritime commercial vessel engaging in commercial activity which
12	requires travel through the ocean waters extending three
13	thousand feet seaward of the territorial sea baseline of the
14	parcel of land acquired by the State at Lipoa point, identified
15	as TMK 2-4-1-001-010-0000.
16	(b) Moneys collected pursuant to this section shall be
17	deposited into the Lipoa point management special fund
18	established by section 171-B.
19	(c) The department shall adopt rules pursuant to chapter
20	91 to carry out the purposes of this section.
