A BILL FOR AN ACT

RELATING TO RAT LUNGWORM DISEASE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the department of SECTION 1. 2 health has reported over seventy cases of rat lungworm disease 3 caused by Angiostrongylus cantonensis from 2001 to 2014. There 4 were many more cases in 2017, including at least eleven on Hawaii island, six on Maui, and one on Oahu. The disease has 5 6 claimed lives and caused crippling chronic disability. The cost 7 of treatment for one severe case can exceed \$1,000,000. The 8 Hawaii island rat lungworm disease working group has been formed 9 at the Daniel K. Inouye college of pharmacy at the University of 10 Hawaii at Hilo and has been conducting research and educational 11 outreach on the disease for the past four years.

12 The purpose of this Act is to appropriate funds to the 13 University of Hawaii at Hilo for research and other activities 14 related to the eradication and prevention of rat lungworm 15 disease.

16 SECTION 2. There is appropriated out of the general
17 revenues of the State of Hawaii the sum of \$ or so much

1	thereof as may be necessary for fiscal year 2018-2019 for	
2	research and other activities related to the eradication and	
3	prevention of rat lungworm disease, including:	
4	(1)	Conducting laboratory testing to determine the
5		effectiveness of deworming rats to reduce rat lungworm
6		transmission;
7	(2)	Conducting laboratory testing of a wide range of
8		commercially available produce washes as well as other
9		potential solutions;
10	(3)	Conducting laboratory testing of commercially
11		available filters and ultraviolet systems to determine
12		effectiveness in catchment; and
13	(4)	Optimizing existing tests or developing new blood-
14		based tests for rat lungworm diagnostics;
15	provided	that the University of Hawaii at Hilo shall collaborate
16	with the department of health, department of land and natural	
17	resources, department of agriculture, and the governor's joint	
18	rat lungworm task force, to create a statewide plan for the	
19	eradication and prevention of rat lungworm disease.	
20	The sum appropriated shall be expended by the University of	
21	Hawaii at Hilo for the purposes of this Act; provided that the

appropriated funds shall not be released until the University of
 Hawaii at Hilo submits to the legislature a comprehensive plan
 describing specific research and other activities it plans to
 undertake to eradicate and prevent rat lungworm disease in the
 State.

6 SECTION 3. This Act shall take effect on July 1, 2018.
