### A BILL FOR AN ACT

RELATING TO EMERGENCY MANAGEMENT.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 127A, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>\$127A-</u> Emergency management watershed team. (a)
5	There is established within the agency an emergency management
6	watershed team.
7	(b) Notwithstanding any other law to the contrary but
8	subject to subsection (c), the emergency management watershed
9	team shall have the authority to access any real property within
10	the State for the limited purpose of clearing the mouth of:
11	(1) Poki Wai stream;
12	(2) Wailoa stream;
13	(3) Nanakuli stream;
14	(4) Ulehawai stream;
15	(5) Mailiilii stream;
16	(6) Kaupuni stream; and
17	(7) Makua stream,

1	in preparation for the imminent approach of a hurricane.
2	(c) The authority of the emergency management watershed
3	team to act pursuant to subsection (b) shall:
4	(1) Only be conferred if the governor has declared that a
5	hurricane poses an imminent threat to the State; and
6	(2) Not grant access to real property controlled by the
7	federal government.
8	(d) The governor shall appoint, without regard to chapter
9	76, employees to serve on the emergency management watershed
10	team, including a lead officer of the team. The lead officer
11	and all other team employees shall serve at the pleasure of the
12	governor.
13	(e) The lead officer of the emergency management watershed
14	team may hire contractors to fulfill the team's duties under
15	this section, pursuant to rules adopted by the governor pursuant
16	to section 127A-25.
17	(f) Notwithstanding any other law to the contrary, the
18	emergency management team, its leadership, its employees, any
19	contractor of the team, and the State shall be immune from
20	criminal and civil liability for trespass upon any real property

1	(1) The person entering the property did so pursuant to
2	this section and any applicable rules adopted by the
3	governor pursuant to section 127A-25; and
4	(2) Immunity shall not apply regarding trespass upon real
5	property controlled by the federal government."
6	SECTION 2. There is appropriated out of the general
7	revenues of the State of Hawaii the sum of \$ or so much
8	thereof as may be necessary for fiscal year 2018-2019 to the
9	Hawaii emergency management agency for the purposes of the Act,
10	including the hiring of staff and contractors necessary to
11	assist the agency in the fulfillment of its duties under this
12	Act.
13	The sum appropriated shall be expended by the Hawaii
14	emergency management agency for the purposes of this Act.
15	SECTION 3. New statutory material is underscored.
16	SECTION 4. This Act shall take effect on July 1, 2018.
