A BILL FOR AN ACT

RELATING TO A SUSTAINABLE ECONOMIC DEVELOPMENT STRATEGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the State cannot
 truly become sustainable without first achieving a sustainable
 economy.

4 To begin working toward a sustainable economy, the 5 legislature enacted Act 8, Special Session Laws of Hawaii 2005, 6 which created the Hawaii 2050 sustainability task force and the 7 Hawaii 2050 sustainability plan. Among its other duties, the 8 legislature required the Hawaii 2050 sustainability task force 9 to submit recommendations on "how best to engage the community 10 in a public discussion to achieve a consensus on the State's preferred future, and coordinate the actions needed to sustain a 11 12 growing and vibrant economy, while maintaining a high quality of 13 life for all residents and visitors." The legislature 14 recognizes that there are uncertainties about the long-term 15 limits of growth in the State, which highlight the need to 16 continue to plan and take action to ensure a sustainable future 17 for the State.

The strategy shall use the 8 benchmarks and indicators of: 9 (1) The Hawaii 2050 sustainability plan, prepared by the 10 auditor pursuant to Act 8, Special Session Laws of 11 Hawaii 2005; 12 (2) The Aloha+ challenge resolution, developed by Hawaii 13 Green Growth; 14 (3) The Hawaii comprehensive economic development 15 strategy, published by the office of planning; and 16 (4)Other potential and recommended indicators, 17 as genuine progress indicators for the State. The strategy 18 shall use data analysis and data mining of these genuine 19 progress indicators to produce recommendations that strengthen 20 Hawaii's indigenous-based economies and create a more diverse 21 and sustainable economy for the State overall.

4 (c) For purposes of this Act:

5 "Genuine progress indicator" means a metric designed to
6 measure the well-being of an entity that takes into account
7 economic, environmental, and social indicators.

8 "Indigenous-based economy" means economic activity derived9 from the native Hawaiian host culture.

10 (d) The state sustainability coordinator shall submit a
11 report of the coordinator's findings and recommendations,
12 including any proposed legislation, to the legislature no later
13 than twenty days prior to the convening of the regular session
14 of 2020.

15 SECTION 3. There is appropriated out of the general 16 revenues of the State of Hawaii the sum of \$ or so much 17 thereof as may be necessary for fiscal year 2018-2019 for the 18 development of a sustainable economic development strategy 19 pursuant to section 2 of this Act.
