

A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Section 26-52, Hawaii Revised Statutes, is
3	amended to read as follows:
4	"§26-52 Department heads and executive officers. The
5	salaries of the following state officers shall be as follows:
6	(1) The salary of the superintendent of education shall be
7	set by the board of education at a rate no greater
8	than [\$250,000 a year.] one hundred ten per cent of
9	the salary of the highest paid teacher in the
10	department of education. The superintendent shall be
11	subject to an annual performance evaluation that is in
12	alignment with other employee evaluations within the
13	department of education and are based on outcomes
14	determined by the board of education; provided that
15	nothing shall prohibit the board of education from
16	conditioning a portion of the salary on performance;

1	(2)	The salary of the president of the University of
2		Hawaii shall be set by the board of regents;
3	(3)	Effective July 1, 2004, the salaries of all department
4		heads or executive officers of the departments of
5		accounting and general services, agriculture, attorney
6		general, budget and finance, business, economic
7		development, and tourism, commerce and consumer
8		affairs, Hawaiian home lands, health, human resources
9		development, human services, labor and industrial
10		relations, land and natural resources, public safety,
11		taxation, and transportation shall be as last
12		recommended by the executive salary commission.
13		Effective July 1, 2007, and every six years
14		thereafter, the salaries shall be as last recommended
15		by the commission on salaries pursuant to section
16		26-56, unless rejected by the legislature; and
17	(4)	The salary of the adjutant general shall be \$85,302 a
18		year. Effective July 1, 2007, and every six years
19		thereafter, the salary of the adjutant general shall
20		be as last recommended by the commission on salaries
21		pursuant to section 26-56, unless rejected by the

1	legislature, except that if the state salary is in
2	conflict with the pay and allowance fixed by the
3	tables of the regular Army or Air Force of the United
4	States, the latter shall prevail."
5	SECTION 2. Section 302A-621, Hawaii Revised Statutes, is
6	amended to read as follows:
7	"§302A-621 Salary; deputy superintendent, assistant
8	superintendents, complex area superintendents. The salaries of
9	the deputy superintendent, assistant superintendents, and
10	complex area superintendents shall be set by the board; provided
11	that the salaries of the deputy superintendent, assistant
12	superintendents, and the complex area superintendents shall not
13	exceed [the superintendent's salary.] one hundred ten per cent
14	of the salary of the highest paid teacher in the department."
15	PART II
16	SECTION 3. Act 90, Session Laws of Hawaii 2014, is amended
17	by amending section 4 to read as follows:
18	"SECTION 4. This Act shall take effect upon its approval[$ au$
19	provided that this Act shall be repealed on June 30, 2024, and
20	section 26 52, Hawaii Revised Statutes, shall be reenacted in
21	the form in which it read on the day prior to the approval date



- of this Act; provided further that any contracts entered into 1
- prior to June 30, 2024, shall remain in effect for the duration 2
- 3 of the contract]."

- 5 SECTION 4. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored. 6
- SECTION 5. This Act shall take effect on July 1, 2018; 7

Report Title:

Department of Education; Superintendent; Deputy Superintendent; Assistant Superintendents; Complex Area Superintendents; Salary

Description:

Adjusts the salaries of the Superintendent, Deputy Superintendent, Assistant Superintendents, and Complex Area Superintendents to be no more than one hundred ten per cent of the salary of the highest paid teacher in the Department of Education. Repeals the sunset date on the Superintendent's annual performance evaluation and adjusted salary.
