BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2 critical physician shortage. The University of Hawaii's most 3 recent physician workforce assessment found that Oahu needs 4 three hundred eighty-one physicians, the Big Island is short one hundred ninety-six physicians, Maui county has a deficit of one 5 6 hundred thirty-nine physicians, and Kauai needs fifty-three 7 physicians. Physician assistants, like nurse practitioners, can 8 help fill this need. 9 The legislature further finds that physician assistants undergo rigorous medical training. They must take a test in 10 11 general medicine in order to be licensed and certified, and they 12 must graduate from an accredited physician assistant program and pass a certification exam. Like physicians and nurse 13 14 practitioners, physician assistants must complete extensive 15 continuing medical education throughout their careers. 16 have shown that when physician assistants practice to the full

- 1 rates and lengths of stay decrease and infection rates go down.
- 2 A Harris poll found extremely high satisfaction rates among
- 3 Americans who interact with physician assistants. The survey
- 4 found that ninety-three per cent of respondents regard physician
- 5 assistants as trusted healthcare providers, ninety-two per cent
- 6 of respondents said that having a physician assistant makes it
- 7 easier to get a medical appointment, and ninety-one per cent of
- 8 respondents believe that physician assistants improve the
- 9 quality of healthcare.
- 10 The legislature further finds that current requirements in
- 11 the Hawaii medical board's administrative rules for the license
- 12 renewal of physician assistants is overly burdensome and
- 13 discourages individuals from entering the profession. Hawaii is
- 14 one of a minority of states that mandate both continuing
- 15 education requirements and continuing certification by the
- 16 National Commission of Certification of Physician Assistants for
- 17 the renewal of a physician assistant license. More than thirty
- 18 states allow physician assistants to renew their licenses by
- 19 meeting continuing education requirements only.
- The legislature believes that Hawaii's licensing standard
- 21 for physician assistants should be aligned with the majority of

- 1 states and the growth of the physician assistant profession
- 2 should be encouraged.
- 3 The purpose of this Act is to specify the continuing
- 4 education requirements for renewal of a physician assistant
- 5 certification and to authorize the Hawaii medical board to
- 6 conduct random audits for compliance.
- 7 SECTION 2. Section 453-5.3, Hawaii Revised Statutes, is
- 8 amended to read as follows:
- 9 "§453-5.3 Physician assistant; licensure required. (a)
- 10 The Hawaii medical board shall require each person practicing
- 11 medicine under the supervision of a physician or osteopathic
- 12 physician, other than a person licensed under section 453-3, to
- 13 be licensed as a physician assistant. A person who is trained
- 14 to do only a very limited number of diagnostic or therapeutic
- 15 procedures under the direction of a physician or osteopathic
- 16 physician shall not be deemed a practitioner of medicine or
- 17 osteopathy and therefore does not require licensure under this
- 18 section.
- 19 (b) The board shall establish medical educational and
- 20 training standards with which a person applying for licensure as
- 21 a physician assistant shall comply. The standards shall be at

- 1 least equal to recognized national education and training
- 2 standards for physician assistants.
- 3 (c) Upon satisfactory proof of compliance with the
- 4 required medical educational and training standards, the board
- 5 may grant state licensure to a person who has been granted
- 6 certification based upon passage of a national certifying
- 7 examination and who holds a current certificate from the
- 8 national certifying entity approved by the board.
- 9 (d) The board shall approve temporary licensure of an
- 10 applicant under this section. The applicant shall have
- 11 graduated from a board approved training program within twelve
- 12 months of the date of application and never taken a national
- 13 certifying examination approved by the board but otherwise meets
- 14 the requirements of this section. The applicant shall file a
- 15 complete application with the board and pay all required fees.
- 16 If the applicant fails to apply for, or to take, the first
- 17 examination scheduled by the board following the issuance of the
- 18 temporary license, fails to pass the examination, or fails to
- 19 receive licensure, all privileges under this section shall
- 20 automatically cease upon written notification sent to the

- 1 applicant by the board. A temporary license shall be issued
- 2 only once to each person.
- 3 (e) Prior to practicing under temporary licensure, holders
- 4 of temporary licenses shall notify the board in writing of any
- 5 and all supervising physicians or osteopathic physicians under
- 6 whom they will be performing services.
- 7 (f) The board shall establish the degree of supervision
- 8 required by the supervising physician or osteopathic physician
- 9 when a physician assistant performs a service within the
- 10 practice of medicine. A physician or osteopathic physician who
- 11 does not supervise a physician assistant's services at the
- 12 degree required by the board shall be deemed to have engaged in
- 13 professional misconduct.
- 14 (g) Any license of a physician assistant may be denied,
- 15 not renewed, revoked, limited, or suspended under section 453-8.
- 16 (h) The board shall establish the application procedure,
- 17 medical educational and training standards, examination
- 18 requirement, if any, and degrees of supervision by rule.
- 19 (i) Every person holding a license under this section
- 20 shall apply for renewal with the board no later than January 31
- 21 of each even-numbered year and pay a renewal fee. Failure to

1	apply for renewal shall constitute a forfeiture of the license
2	that may only be restored upon written application for
3	restoration and payment to the board of a restoration fee.
4	(j) A physician assistant shall be in compliance with
5	continuing education requirements by obtaining forty credit
6	hours in:
7	(1) A category 1 continuing medical education program
8	accredited by the American Medical Association;
9	(2) A category 1A continuing medical education program
10	accredited by the American Osteopathic Association; or
11	(3) Other category 1 or 1A continuing medical education
12	approved by the board through rules.
13	To determine compliance, the board may conduct random audits of
14	physician assistants' continuing education documentation. A
15	physician assistant selected for audit shall be notified by the
16	board. Within sixty days of notification, the physician
17	assistant shall provide the board documentation to verify
18	compliance with the continuing medical education requirements.
19	$\left[\frac{(j)}{(k)}\right]$ A license that has been forfeited for one
20	renewal term shall be automatically terminated and cannot be
21	restored. A new application for licensure shall be required."

- 1 SECTION 3. This Act does not affect rights and duties that
- 2 matured, penalties that were incurred, and proceedings that were
- 3 begun before its effective date.
- 4 SECTION 4. Statutory material to be repealed is bracketed
- 5 and stricken. New statutory material is underscored.
- 6 SECTION 5. This Act shall take effect on July 1, 3000.
