A BILL FOR AN ACT

RELATING TO WATERSHEDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Hawaii has a limited
- 2 supply of water and that it is important to protect this supply.
- 3 Further, the legislature finds that improving, repairing, and
- 4 maintaining the various watersheds throughout the State serves
- 5 an important and necessary public purpose by ensuring that the
- 6 State has a continuous and sustainable supply of water.
- 7 Accordingly, the purpose of this Act is to appropriate
- 8 moneys for the department of land and natural resources to
- 9 conduct improvements, repairs, and maintenance of watersheds
- 10 throughout the State. The legislature finds and declares that
- 11 the appropriations made in this Act are for a public purpose in
- 12 accordance with article VII, section 4 of the Hawaii State
- 13 Constitution.
- 14 SECTION 2. There is appropriated out of the natural area
- 15 reserve fund the sum of \$ or so much thereof as may be
- 16 necessary for fiscal year 2018-2019 for the following:

11		(4)	Construction and installation of a protective fence
12			for the central Opaeula watershed on the island of
13			Oahu;
14		(5)	Construction and installation of a protective fence in
15			the Waiawa rain forest on the island of Oahu; and
16	st	(6)	Repairs of the protective fence located in the
17			Keauhou, Kau area on the island of Hawaii.
18		The	sum appropriated shall be expended by the department of
19	land	and	natural resources for the purposes of this Act.

SECTION 3. This Act shall take effect on July 1, 2018.
