### A BILL FOR AN ACT

RELATING TO THE ELECTRONIC PRESCRIPTION ACCOUNTABILITY SYSTEM.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that opioid addiction is

2 a growing problem in Hawaii. According to data from the federal

3 Centers for Disease Control and Prevention, drug overdose deaths

4 in Hawaii increased by eighty-three percent from 2006 to 2014, a

5 growth rate more than double the national average of thirty-

6 seven percent. Nearly half of those deaths are a result of

7 prescription opioids.

8 Furthermore, the Centers for Disease Control also noted

9 that sales of prescription opioids in the United States nearly

10 quadrupled between 1999 and 2014, but there has not been an

11 overall change in the amount of pain Americans report. The

12 legislature further finds that the connection between increased

13 prescriptions for opiates, and similar increases in overdose

14 deaths and substance abuse problems from those prescriptions

15 must be addressed.

16 Accordingly, the purpose of this Act is to make use of data

17 available within the Electronic Prescription Accountability

- 1 System to inform prescribers on their opioid prescription rates
- 2 in relation to their peers by grouping similarly situated
- 3 practitioners and assigning them a percentile rank within the
- 4 group according to total opiate prescriptions prescribed for the

- 6 ranking solely for the purpose of increasing awareness of their
- 7 prescription habits; percentile ranking information produced

- 11 SECTION 2. Section 329-103, Hawaii Revised Statutes, is
- 12 amended to read as follows:
- "[+] §329-103[+] Designated state agency. The designated

- 15 (1) Oversee and administer the collection of information
- under the system;
- 17 (2) Control access to the information in the system; [and]
- 18 (3) Produce exception reports as defined in section 329-
- 19 1 [-];
- 20 (4) Annually determine, through the electronic

2		volume of prescriptions for opiates contained in
3		Schedule II controlled substances as defined in
4		section 329-16 and Schedule III controlled substances
5		as defined in 329-18 issued by practitioners
6		registered under section 329-101; provided, however,
7		that mean and median prescription quantities and
8		volumes shall be determined within categories of
9		practitioners of a similar specialty or practice type
10		as determined by the department;
11	(5)	Work in conjunction with the respective boards of
12		licensure to annually determine each practitioner's
13		Schedule II and Schedule III opiate prescribing
14		quantity and volume, and the practitioner's standing
15		with regard to the mean and median quantity and volume
16		for the practitioner's category of specialty or
17		practice type; provided, however, that the
18		practitioner's standing shall be expressed as a
19		percentile ranking for the practitioner within the
20		practitioner's category. Each practitioner whose
21		prescribing exceeds the mean or median within the

1		practitioner's category shall be sent notice of the
2		practitioner's percentile ranking in a manner
3		determined by the department. Any practitioner may
4		request the practitioner's own percentile ranking
5		within the practitioner's own category of practice.
6		The ranking determined for each practitioner shall be
7		confidential, shall be distributed by the department
8		or by the relevant board of licensure only to the
9		practitioner to which the information pertains, and
10		shall not be admissible as evidence in a civil or
11		criminal proceeding or be the sole basis for
12		investigation by a licensure board; and
13	(6)	Coordinate with the respective boards of licensure to
14		make resources available to prescribers regarding ways
15		to change prescribing practices and incorporate
16		alternative pain management options into a
17		prescriber's practice."
