A BILL FOR AN ACT

RELATING TO HOMELESS SERVICES PROVIDERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the State					
2	appropriates tens of millions of dollars each year to support					
3	efforts to address homelessness. A large portion of these					
4	moneys goes to provider agencies that are contracted to provide					
5	services to homeless persons on behalf of the State. The					
6	legislature believes it would be fiscally prudent to encourage					
7	more accountability by requiring that the department of human					
8	services track these appropriations and measure the					
9	effectiveness of these efforts based on objective indicia.					
10	Accordingly, the purpose of this Act is to require the					
11	department of human services to develop a system that:					
12	(1) Tracks appropriations made for contracts with provider					
13	agencies that provide services to homeless persons on					
14	behalf of the State;					
15	(2) Measures the effectiveness of services provided by					
16	these agencies; and					

(3) Is regularly updated and accessible to the public.

1	SECTION 2. Section 346-365, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"[+]§346-365[+] Program administration. (a) To the
4	extent that appropriations are made available, the department
5	may contract with a provider agency to administer homeless
6	facilities or any other program for the homeless created by this
7	part. The selection of provider agencies to administer homeless
8	facilities or any other program for the homeless authorized by
9	this part shall not be subject to chapters 42F, 102, and 103.
10	The selection of provider agencies shall be subject to
11	qualifying standards and criteria established by rule.
12	(b) The provider agency shall be qualified by the
13	department to operate and manage a homeless facility or any
14	other program for the homeless authorized by this part pursuant
15	to standards and criteria established by rules for eligibility.
16	(c) Notwithstanding the financial audit requirements of
17	section 346-371, the department shall develop a system that:
18	(1) Tracks appropriations made for contracts with provider
19	agencies under subsection (a);
20	(2) Records the demographics of the homeless persons
21	served by each provider agency under subsection (a);

1	(3)	Meas	ures the effectiveness of services provided to
2		home	less persons by provider agencies that receive
3		mone	ys under subsection (a), based on objective
4		indi	cia determined by the department, including:
5		(A)	The amount of moneys an agency receives under
6			subsection (a);
7		(B)	The number of homeless persons served by the
8			agency and, of this number, the number of
9			chronically homeless persons served by the
10			agency;
11		<u>(C)</u>	The average length of stay by homeless persons
12			the agency provided shelter to;
13		(D)	The number of homeless persons placed into
14			permanent housing by the agency and the average
15			length of time these persons remained in
16			permanent housing;
17		<u>(E)</u>	The number of homeless persons who, after
18			placement into permanent housing by the agency,
19			returned to homelessness; and
20		(F)	Any other relevant indicia;

1	(4)	Is accessible to the public via an online platform;
2		provided that the online platform allows the public to
3		sort and filter data by:
4		(A) The type of service provided by the agency,
5		including but not limited to emergency housing,
6		transitional housing, or rapid rehousing; and
7		(B) The name of the provider agency; and
8	(5)	Is updated on a quarterly basis using data obtained
9		from the State's homeless management information
10		system, also known as HMIS."
