A BILL FOR AN ACT

RELATING TO CHILDLIKE SEX DOLLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a
- 2 disturbing trend involving the use of childlike sex dolls. Not
- 3 only do the physical features of these dolls resemble minor
- 4 children, but some dolls even have robotic properties that allow
- 5 their "personalities" to be customized.
- 6 The legislature recognizes that a correlation exists
- 7 between possession of these dolls and possession of and
- 8 participation in child pornography. As the United States
- 9 Supreme Court has pointed out, obscene material is often used to
- 10 methodically seduce child victims. The dolls and robots, some
- 11 of which have a programmable "rape function", are intrinsically
- 12 related to abuse of minors. They can cause the exploitation,
- 13 objectification, abuse, and rape of minors, as well as increase
- 14 the likelihood of rapes by teaching potential rapists how to
- 15 overcome resistance and subdue their victims.

1	Therefore, the purpose of this Act is to establish the
2	elony offense of importation, sale, or possession of a
3	childlike sex doll.
4	SECTION 2. Chapter 712, Hawaii Revised Statutes, is
5	mended by adding a new section to part II to be appropriately
6	designated and to read as follows:
7	"§712- Importation, sale, or possession of a childlike
8	sex doll. (1) A person commits the offense of importation,
9	sale, or possession of a childlike sex doll if the person
10	ntentionally, knowingly, or recklessly:
11	(a) Imports or causes to be imported into the State a
12	childlike sex doll;
13	(b) Sells, distributes, or otherwise provides to another
14	person a childlike sex doll; or
15	(c) Possesses a childlike sex doll.
16	(2) The importation, sale, or possession of ten or fewer
17	childlike sex dolls is a class C felony.
18	(3) The importation, sale, or possession of more than ten
19	childlike sex dolls is a class B felony.
20	(4) For purposes of this section, "childlike sex doll"

means an anatomically correct doll, mannequin, or robot with

- 1 features that resemble those of a minor and that is designed or
- 2 intended for use in a sexual act."
- 3 SECTION 3. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 4. New statutory material is underscored.
- 7 SECTION 5. This Act shall take effect upon its approval.
