A BILL FOR AN ACT

RELATING TO CHILDREN'S HEALTH CARE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that keiki care was a
- 2 pilot program of the department of human services med-QUEST
- 3 division that started in 2008 as a result of Act 236, Session
- 4 Laws of Hawaii 2007. The pilot program provided health
- 5 insurance to 1,974 children as of August 31, 2008. The intended
- 6 purpose of the pilot program was to provide health insurance for
- 7 children who were otherwise uninsured provided that they were
- 8 not eligible for other state or federal health care coverage.
- 9 The state paid \$25.50 per child per month for keiki care at the
- 10 total cost of \$50,337 per month. On November 1, 2008, the
- 11 governor discontinued the pilot program more than two years
- 12 short of the span intended by Act 236.
- 13 Although estimates of the number of uninsured children in
- 14 the State vary, there is a gap group that is ineligible for any
- 15 state or federal health care coverage. The majority of children
- 16 in this gap group are those whose family income is at or just
- 17 over three hundred per cent of the federal poverty level.

- 1 Others in this group may include infants born to uninsured
- 2 mothers, immigrants with temporary visas, and undocumented
- 3 immigrants who have been in Hawaii for less than six months.
- 4 The United States Census Bureau estimates that the total number
- 5 of children in Hawaii who fell into the gap group in 2016 was
- **6** 6,897.
- 7 Children who remain uninsured typically do not receive an
- 8 appropriate level of medical care. Children who lack a source
- 9 of care or who turn regularly to a hospital emergency department
- 10 are unlikely to receive preventive care or early and regular
- 11 management of acute or chronic health conditions.
- 12 A study performed by the Urban Institute, a nonpartisan
- 13 economic and social policy research organization, showed that
- 14 regardless of age, race, ethnicity, income, or health status,
- 15 uninsured children were much less likely to have received a
- 16 well-child checkup within the past year and were more likely
- 17 than insured children to report an unmet need for medical care
- 18 that was associated with concerns about cost.
- 19 Health insurance helps children and youth receive regular
- 20 health care so they can participate in school and other
- 21 activities. Often, parents experience hardship when an

- 1 uninsured child is sick because of the added stress caused by
- 2 the child's medical bills.
- 3 The purpose of this Act is to establish the Hawaii infant
- 4 health care program and the Hawaii children's health care
- 5 program as temporary three-year pilot programs to expand and
- 6 monitor health care coverage for children in Hawaii by:
 - (1) Providing continuous, quality health care services to uninsured newborn children who are one day, but not more than thirty days of age through the Hawaii infant care program; provided that these children may enroll in the Hawaii children's health care program upon
- reaching thirty-one days of age;
- 13 (2) Providing health care coverage to certain children who
- are at least thirty-one days, but less than nineteen
- 15 years old through a public-private partnership between
- 16 the department of human services and one or more
- managed care plans operating in the State under
- chapter 432, Hawaii Revised Statutes, that offer
- 19 accident and health or sickness insurance plans; and
- 20 (3) Appropriating funds for these pilot programs.

- 1 SECTION 2. (a) There is established the Hawaii infant
- 2 health care program as a temporary three-year pilot program to
- 3 provide continuous, quality health care services to uninsured
- 4 newborn children living in Hawaii who are one day, but not more
- 5 than thirty days of age, with up to \$10,000 of health care
- 6 assistance per eligible child, subject to the appropriation of
- 7 general funds for the program.
- 8 (b) It is not the intent of the legislature to discourage
- 9 employers from offering to pay, or from paying for, dependent
- 10 coverage for their employees, nor that this Act supplant
- 11 employer-sponsored dependent coverage plans.
- 12 (c) Services provided pursuant to the Hawaii infant health
- 13 care program shall be the same as services for children covered
- 14 by med-QUEST.
- 15 (d) The department may contract with an appropriate entity
- 16 to provide health care services required by the Hawaii infant
- 17 health care program. The department of human services or its
- 18 designated contractor shall directly reimburse any health care
- 19 provider or managed care plan providing services to infants
- 20 under the Hawaii infant health care program, subject to the
- 21 appropriation of general funds for the program.

- 3 The sum appropriated shall be expended by the department of

- 5 SECTION 8. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$ or so much
- 7 thereof as may be necessary for fiscal year 2018-2019 for
- 8 administrative costs, including the purchase of computer
- 9 equipment, office furniture, and other supplies and equipment
- 10 necessary to implement section 2 of this Act.
- 11 The sum appropriated shall be expended by the department of
- 12 human services for the purposes of section 2 of this Act.
- 13 SECTION 9. This Act shall take effect on July 1, 3000 and
- 14 shall be repealed on June 30, 2021.
