# A BILL FOR AN ACT

RELATING TO HIGHER EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 304A, Hawaii Revised Statutes, is
- 2 amended by adding a new section to subpart B of part II to be
- 3 appropriately designated and to read as follows:
- 4 "§304A- First-generation matching grant program. (a)
- 5 There is established the first-generation matching grant program
- 6 to be administered by the University of Hawaii. The purpose of
- 7 the program shall be to provide private donors with a matching
- 8 grant incentive to make financial contributions toward grant-
- 9 based student financial aid for undergraduate students who
- 10 demonstrate financial need and whose parents have not earned a
- 11 baccalaureate or higher degree.
- 12 For the purposes of this subsection, "parent" means any
- 13 parent or legal guardian of a student of the university or any
- 14 person in a parental relationship to the student, as determined
- 15 by the university.
- 16 (b) All appropriations and private contributions for the
- 17 program shall be deposited into the University of Hawaii

1	scholarship and assistance special fund established pursuant to
2	section 304A-2159. Program appropriations shall be allocated by
3	the university to match private contributions on a dollar-for-
4	dollar basis. Private contributions pledged for the purposes of

6	(d)	To be eligible for a grant pursuant to this section,
7	an applic	ant shall:
8	(1)	Be a resident for tuition purposes as determined
9		pursuant to section 304A-402;
10	(2)	Qualify as a first-generation college student under
11		the criteria set forth in subsection (a);
12	(3)	Be enrolled at the university for a minimum of six
13		credit hours per term as a degree-seeking
14		undergraduate student;
15	(4)	Have properly submitted a free application for federal
16		student aid; and
17	(5)	Meet additional eligibility requirements as
18		established by the university.
19	<u>(e)</u>	The award amount shall be based on the student's
20	remaining	need assessment after consideration of all other

2	state, or	private sources; provided that:	
3	(1)	The first priority of funding shall be given to	
4		students who demonstrate need by qualifying and	
5		receiving federal pell grant funds towards tuition and	
6		fees per term; and	
7	(2)	An award may not exceed the university's estimated	
8		annual cost of attendance for the student to attend	
9		the university.	
10	<u>(f)</u>	Grant awards made under this section shall be	
11	determined by the university subject to the availability of		
12	funds and	shall be disbursed no earlier than the start of a term	
13	or as determined by the university.		
14	<u>(g)</u>	The university shall report all awards granted under	
15	this section in its annual report for the University of Hawaii		
16	scholarship and assistance special fund as required by section		
17	<u>304A-2159.</u> "

- 1 transferred by the university from the tuition and fees special
- 2 fund pursuant to section [+]304A-2153[+], [and] appropriations
- 3 for the state scholars program[+], and state appropriations and
- 4 private contributions for the first-generation matching grant
- 5 program; provided that state funds appropriated for any
- 6 scholarship program, including but not limited to the B Plus
- 7 scholarship program, the Hawaii state scholars program, [and]
- 8 the workforce development scholarship program, and all funds
- 9 deposited into the fund for the first-generation matching grant
- 10 program, shall be kept in a separate and distinct account."
- 11 SECTION 3. Statutory material to be repealed is bracketed
- 12 and stricken. New statutory material is underscored.
- SECTION 4. This Act shall take effect on July 1, 2050.
