### A BILL FOR AN ACT

RELATING TO THE HAWAII HEALTH SYSTEMS CORPORATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 323F, Hawaii Revised Statutes, is
- 2 amended by adding a new part to be appropriately designated and
- 3 to read as follows:
- 4 "PART . COUNTY MANAGEMENT AND OPERATION OF
- 5 THE EAST HAWAII REGIONAL SYSTEM FACILITIES
- 6 §323F-A Transfer of right and responsibility to manage,
- 7 operate, and provide health care services in a facility of the
- 8 east Hawaii regional system to the county of Hawaii.
- 9 Notwithstanding any other law to the contrary, the governor,
- 10 with the assistance of the chief executive officer of the
- 11 corporation, and the regional chief executive officer of the
- 12 east Hawaii regional system, or their designees, shall transfer
- 13 the right and responsibility to manage, operate, and otherwise
- 14 provide health care services at one or more facilities of the
- 15 east Hawaii regional system, including Hilo medical center, to
- 16 the county of Hawaii.

§323F-B Appropriations to the county of Hawaii for the 1 management and operation of east Hawaii regional system 2 3 facilities. For the management and operation of the east Hawaii regional system facilities transferred under this part, the 4 State shall make an annual appropriation to the county of Hawaii 5 that is equal to the level of the appropriation made in fiscal 6 year 2016-2017 to the Hawaii health systems corporation for the 7 transferred facilities, as adjusted annually based upon the 8 Consumer Price Index for All Urban Consumers (CPI-U), All Items, 9 10 for Honolulu. §323F-C General fund transfers to the county of Hawaii for 11 collective bargaining unit cost adjustments. In addition to the 12 appropriation amounts required under section 323F-B, the State 13 shall also make annual transfers of general funds to the county 14 15 of Hawaii to pay for any collective bargaining unit cost 16 adjustments of an appropriate bargaining unit until such time that the county of Hawaii, under section 89-6(d), has at least 17 half of the votes of the public employer for the purpose of 18 negotiating a collective bargaining agreement for that 19 20 bargaining unit."

- 1 SECTION 2. The appropriations and general fund transfers
- 2 under sections 323F-B and 323F-C in section 1 of this Act shall
- 3 be made in satisfaction of article VIII, section 5, of the state
- 4 constitution, on the transfer of mandated programs.
- 5 SECTION 3. In codifying the new sections added by section
- 6 1 of this Act, the revisor of statutes shall substitute
- 7 appropriate section numbers for the letters used in designating
- 8 the new sections in this Act.
- 9 SECTION 4. This Act shall take effect upon its approval.
