

A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the University of
- 2 Hawaii center on aging is a key partner in the aging network and
- 3 provides education, consultation, research, and program
- 4 development and evaluation in collaboration with government and
- 5 service providers.
- 6 The legislature also finds that gerontological education
- 7 and workforce development are critical to preparing for the
- 8 State's aging population. Hawaii's population is aging at a
- 9 faster rate than the rest of the nation, and kupuna in Hawaii
- 10 have the highest life expectancy in the nation. Between 1980
- 11 and 2010, Hawaii's population of individuals age sixty and older
- 12 increased one hundred forty per cent. By 2030, it is expected
- 13 that twenty-three per cent of the State's overall population
- 14 will be older adults.
- 15 The legislature further finds that the development of
- 16 Hawaii's workforce to care for and address the needs of older
- 17 adults has not kept pace with the growing population of kupuna.

- 1 The University of Hawaii center on aging has recognized this gap
- 2 and will be well-equipped to address the need with two
- 3 additional faculty positions. Currently staffed only by a
- 4 director, the center on aging's capacity to expand and create
- 5 educational initiatives is limited. An associate professor
- 6 position and an associate specialist position will enable the
- 7 center on aging to achieve its educational mission.
- 8 Specifically, the center on aging can lead in workforce
- 9 development, promoting and teaching gerontology courses on
- 10 campus and providing continuing education and training in the
- 11 community. The development and teaching of gerontology courses
- 12 will be invaluable, enabling students from all disciplines,
- 13 including health, social work, public health, social sciences,
- 14 business, architecture, engineering, and urban planning, to view
- 15 their studies with an aging lens and to better prepare for,
- 16 support, and address the needs of older adults and caregivers.
- 17 In addition, the center on aging will be able to partner with
- 18 the community to provide data; conduct research; conduct program
- 19 and policy development and evaluation; and promote innovation,
- 20 including adoption and translation of evidence-based and best
- 21 practices.

- 1 The purpose of this Act is to fund an associate professor
- 2 position and an associate specialist position within the
- 3 University of Hawaii center on aging.
- 4 SECTION 2. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$92,000 or so much
- 6 thereof as may be necessary for fiscal year 2017-2018 and the
- 7 same sum or so much thereof as may be necessary for fiscal year
- 8 2018-2019 to fund one full-time equivalent (1.0 FTE) associate
- 9 professor position within the University of Hawaii center on
- 10 aging.
- 11 The sums appropriated shall be expended by the University
- 12 of Hawaii for the purposes of this Act.
- 13 SECTION 3. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$92,000 or so much
- 15 thereof as may be necessary for fiscal year 2017-2018 and the
- 16 same sum or so much thereof as may be necessary for fiscal year
- 17 2018-2019 to fund one full-time equivalent (1.0 FTE) associate
- 18 specialist position within the University of Hawaii center on
- 19 aging.
- The sums appropriated shall be expended by the University
- 21 of Hawaii for the purposes of this Act.

1 SECTION 4. This Act shall take effect on July 1, 2017.
