A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the use of illegal
- 2 aerial fireworks during New Year's celebrations on Oahu
- 3 continues to cause significant disruption and concern. In the
- 4 past two years alone, the Honolulu police department has
- 5 received several thousand complaints and made numerous arrests
- 6 relating to illegal fireworks usage during the months of
- 7 November and December. In addition, illegal fireworks have
- 8 caused injuries and damaged property, including a destructive
- 9 fire to a historical Ewa home in 2015 and the death of an Oahu
- 10 resident in 2016. The ease of importing illegal explosives into
- 11 the State is a public safety concern that impacts all Hawaii
- 12 residents and businesses.
- 13 The legislature further finds that the inspection of
- 14 shipping containers, whether by the State or counties, is a
- 15 major element in the fight against terrorism and illegal
- 16 fireworks. Particularly in light of the State's geographical
- 17 isolation and the numerous containers arriving by ship, it is

- 1 imperative that the State broaden its inspection of incoming
- 2 shipping containers. Over ninety per cent of the more than two
- 3 hundred thousand shipping cargo containers that arrive in Hawaii
- 4 each year are from the continental United States. Only a small
- 5 fraction of these containers, however, are inspected by
- 6 government agencies. The lack of sufficient cargo inspections
- 7 means that there is ample opportunity for illegal fireworks and
- 8 explosives to be smuggled into the State. The legislature also
- 9 finds that increased inspections need to be carefully crafted to
- 10 avoid delays and inefficiencies in harbor operations that could
- 11 impede commerce. One approach is to use explosive-sniffing
- 12 dogs, which the sheriff division of the department of public
- 13 safety currently have at their disposal, to inspect cargo after
- 14 arrival at the harbors.
- The legislature further finds that the "Report of the
- 16 Illegal Fireworks Task Force to the Legislature for the Regular
- 17 Session of 2011", which was prepared in accordance with Act 170,
- 18 Session Laws of Hawaii 2010, made recommendations in an effort
- 19 to reduce illegal firework use and importation. These
- 20 recommendations include increased fireworks fees and fines,

- 1 increased random inspections of cargo containers, and promotion
- 2 of cooperation among stakeholders.
- 3 The purpose of this Act is to implement recommendations
- 4 from the "Report of the Illegal Fireworks Task Force to the
- 5 Legislature for the Regular Session of 2011" and establish a
- 6 shipping container inspection program using explosive-sniffing
- 7 dogs to inspect cargo shipments after arrival at the harbors.
- 8 SECTION 2. Chapter 266, Hawaii Revised Statutes, is
- 9 amended by adding three new sections to be appropriately
- 10 designated and to read as follows:
- 11 "\$266-A Power to inspect shipping containers. (a) The
- 12 State shall have the authority to inspect cargo shipping
- 13 containers being shipped and transported through state harbors
- 14 and harbor facilities for contraband or other harmful items. In
- 15 addition to any other powers provided by law, the department of
- 16 public safety, sheriff division, may in its discretion inspect
- 17 any shipping container situated anywhere at any commercial
- 18 harbor, as defined in section 266-1, or work site to detect and
- 19 confiscate any material, including explosives but excluding
- 20 fireworks regulated under chapter 132D, constituting a direct or
- 21 indirect threat to the security of life or property in Hawaii.

- 4 same sum or so much thereof as may be necessary for fiscal year
- 5 2018-2019 to be deposited into the shipping container inspection
- 6 program special fund established pursuant to this Act.
- 7 SECTION 6. There is appropriated out of the shipping
- f 8 container inspection program special fund the sum of \$50,000 or
- 9 so much thereof as may be necessary for fiscal year 2017-2018
- 10 and the same sum or so much thereof as may be necessary for
- 11 fiscal year 2018-2019 for costs to establish and administer the
- 12 shipping container inspection program, including the purchase,
- 13 care, and handling of at least two explosive-sniffing dogs.
- 14 The sums appropriated shall be expended by the department
- 15 of public safety for the purposes of this Act.
- 16 SECTION 7. In codifying the new sections added by section
- 17 2 of this Act, the revisor of statutes shall substitute
- 18 appropriate section numbers for the letters used in designating
- 19 the new sections in this Act.
- 20 SECTION 8. Statutory material to be repealed is bracketed
- 21 and stricken. New statutory material is underscored.

Report Title:

Department of Public Safety; Sheriff Division; Department of Transportation; Shipping Container Inspection Program; Illegal Fireworks; Explosives; Fees; Penalties; Appropriation

Description:

Increases maximum fines for violations of the fireworks control law. Appropriates funds for the Department of Public Safety, Sheriff Division, in collaboration with the Department of Defense, Department of Transportation, and other federal and state agencies, to establish a shipping container inspection program to randomly inspect shipping containers for illegal fireworks and explosives using explosive-sniffing dogs and establishes requirements for the inspection program. Requires the Department of Transportation to assess a fee on all shipping containers to fund the program.
