

A BILL FOR AN ACT

RELATING TO THE CONSTRUCTION OF RAIL TRANSIT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. (a) The auditor shall contract with an
2	independent auditor to conduct a comprehensive financial and	
3	managemen	t audit of the Honolulu authority for rapid
4	transportation. The audit shall include an examination of the	
5	managemen	t and operations of the Honolulu authority for rapid
6	transportation, including but not limited to:	
7	(1)	The Honolulu authority for rapid transportation's
8		financial plan and related systems of accounting;
9	(2)	The efficacy of the Honolulu authority for rapid
10		transportation's fiscal and management policies,
11		practices, and processes associated with the plans,
12		design, bidding, and construction of the Honolulu rail
13		transit project;
14	(3)	All contracts awarded for, and expenditures associated
15		with, the Honolulu rail transit project, including
16		payments to contractors, subcontractors, and
17		consultants

1	(4)	Expenditures by the Honolulu authority for rapid	
2		transportation for personnel costs, lease rent, and	
3		any other costs associated with its management and	
4		operations; and	
5	(5)	Factors contributing to escalating costs associated	
6		with the Honolulu rail transit project.	
7	(b)	The auditor shall submit a report of the findings and	
8	recommendations of the independent audit, including any proposed		
9	legislation, to the legislature no later than twenty days prior		
10	to the convening of the regular session of 2018. The		
11	recommendations shall address any deficiencies identified as a		
12	result of the audit and include recommendations to eliminate		
13	waste within the Honolulu authority for rapid transportation and		
14	to make the operations of the authority more efficient.		
15	SECTION 2. There is appropriated out of the general		
16	revenues of the State of Hawaii the sum of \$ or so muc		
17	thereof as may be necessary for fiscal year 2017-2018 to conduc		
18	a comprehensive audit of the Honolulu authority for rapid		
19	transportation by an independent auditor.		
20	The sum appropriated shall be expended by the auditor for		
21	the purp	oses of this Act.
