A BILL FOR AN ACT

RELATING TO WORKERS' COMPENSATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 386-79, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "§386-79 Medical examination by employer's physician. (a)
- 4 After an injury and during the period of disability, the
- 5 employee, whenever ordered by the director of labor and
- 6 industrial relations, shall submit to examination, at reasonable
- 7 times and places, by a duly qualified physician or surgeon
- 8 designated and paid by the employer. The employee shall have
- 9 the right to have a physician [or], surgeon, or chaperone
- 10 designated and paid by the employee present at the examination,
- 11 which right, however, shall not be construed to deny to the
- 12 employer's physician the right to visit the injured employee at
- 13 all reasonable times and under all reasonable conditions during
- 14 total disability. The employee, with the consent of the
- 15 employer's physician or surgeon, shall also have the right to
- 16 record such examination by a recording device designated and
- 17 paid for by the employee.

1 If an employee refuses to submit to, or the employee or the 2 employee's designated chaperone in any way obstructs such 3 examination, the employee's right to claim compensation for the 4 work injury shall be suspended until the refusal or obstruction 5 ceases and no compensation shall be payable for the period 6 during which the refusal or obstruction continues. 7 In cases where the employer is dissatisfied with the 8 progress of the case or where major and elective surgery, or either, is contemplated, the employer may appoint a physician or 9 10 surgeon of the employer's choice who shall examine the injured 11 employee and make a report to the employer. If the employer 12 remains dissatisfied, this report may be forwarded to the 13 director. 14 Employer requested examinations under this section shall 15 not exceed more than one per case unless good and valid reasons 16 exist with regard to the medical progress of the employee's 17 treatment. The cost of conducting the ordered medical 18 examination shall be limited to the complex consultation charges 19 governed by the medical fee schedule established pursuant to 20 section 386-21(c)."

- 1 SECTION 2. This Act does not affect rights and duties that
- 2 matured, penalties that were incurred, and proceedings that were
- 3 begun before its effective date.
- 4 SECTION 3. Statutory material to be repealed is bracketed
- 5 and stricken. New statutory material is underscored.
- 6 SECTION 4. This Act shall take effect on July 1, 2050.

Report Title:

Workers' Compensation; Medical Examination; Chaperone; Recording Devices

Description:

Permits an injured employee to designate a chaperone to be present during workers' compensation medical exams and, with all parties' consent, to record exams. Specifies that a chaperone is included in the existing prohibition on employee refusal or disruption of medical exams. (HB978 HD1)
