## HOUSE CONCURRENT RESOLUTION

REQUESTING THE LEGISLATIVE REFERENCE BUREAU TO CONVENE A TASK FORCE TO STUDY AND MAKE RECOMMENDATIONS REGARDING STUDENT LOAN DEBT RELIEF.

1 WHEREAS, student loan debt has grown significantly over the 2 past few decades and currently stands at historically high 3 levels; and 4

5 WHEREAS, borrowers of student loans are incurring debt 6 burdens that will be difficult to repay and will hinder their 7 ability to achieve major life goals, such as owning a home, 8 starting and raising families, investing in a small business, or 9 saving for retirement; and

11 WHEREAS, a February 2018 report by the Levy Economics 12 Institute of Bard College concluded that government cancellation 13 of student debt would likely increase the creation of jobs, 14 reduce unemployment, and lead to a significant increase in gross 15 domestic product; now, therefore,

BE IT RESOLVED by the House of Representatives of the 17 18 Twenty-ninth Legislature of the State of Hawaii, Regular Session of 2018, the Senate concurring, that the Legislative Reference 19 Bureau is requested to convene a task force to study and make 20 recommendations, including any proposed policies and 21 legislation, regarding student loan debt relief and how to ease 22 23 this burden on the residents of Hawaii; and 24 25 BE IT FURTHER RESOLVED that the task force comprise: 26

5 BE IT FURTHER RESOLVED that the Legislative Reference 6 Bureau is also requested to provide staff support for the task 7 force, including drafting the report and any proposed 8 legislation; and

BE IT FURTHER RESOLVED that the task force is requested to submit a report of its findings and recommendations, including any proposed legislation, to the Legislature at least 20 days prior to the convening of the Regular Session of 2019; and 14
