BE IT FURTHER RESOLVED that the Task Force study future 1 uses for the vacated Fire Station site, including recreational 2 and educational uses, such as bicycle rental and maintenance 3 stations and a Pearl City historic museum; and 4 5 BE IT FURTHER RESOLVED that the Task Force shall consist of 6 7 eight members as follows: 8 9 The Chairperson of the Board of Land and Natural (1)Resources, or the Chairperson's designee, who shall 10 serve as the chairperson of the Task Force; 11 12 (2) A senator selected by the President of the Senate; 13 14 (3) A representative selected by the Speaker of the House 15 of Representatives; 16 17 (4) The City and County of Honolulu Council Member 18 representing District 8, or the Council Member's 19 designee; 20 21 The Fire Chief of the City and County of Honolulu Fire (5) 22 Department, or the Fire Chief's designee; 23 24 The Chairperson of the Pearl City Neighborhood Board, (6) 25 or the Chairperson's designee; 26 27 (7) The Chairperson of the Friends of the Pearl Harbor 28 Historic Trail, or the Chairperson's designee; and 29 30 (8) The principal of Lehua Elementary School, or the 31 principal's designee; and 32 33 BE IT FURTHER RESOLVED that all members of the Task Force 34 be selected or designated within 30 days of adjournment sine die 35 of the Regular Session of 2018 and that the Task Force convene 36 its initial meeting within 30 days of selection or designation 37 of the last member; and 38 39 BE IT FURTHER RESOLVED that no member shall be made subject 40 to chapter 84, Hawaii Revised Statutes, solely because of that 41 member's participation as a member of the Task Force; and

1 BE IT FURTHER RESOLVED that the Task Force shall be exempt from chapter 92, Hawaii Revised Statutes; and 2 3 BE IT FURTHER RESOLVED that the Task Force submit a report 4 of its findings and recommendations, including any proposed 5 legislation, to the Legislature no later than 20 days prior to 6 the convening of the Regular Session of 2020; and 7 8 BE IT FURTHER RESOLVED that certified copies of this 9 Concurrent Resolution be transmitted to the Chairperson of the 10 Board of Land and Natural Resources, the City and County of 11 Honolulu Council Member representing District 8, the Fire Chief 12 of the City and County of Honolulu Fire Department; the 13 Chairperson of the Pearl City Neighborhood Board; the President 14 of the Aiea Community Association; the Chairperson of the 15 Friends of the Pearl Harbor Historic Trail; and the Principal of 16 Lehua Elementary School. 17
