A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF TRANSPORTATION, AIRPORTS DIVISION, PROJECT ADJUSTMENT FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The department of transportation, airports
- 2 division, finds that the Supplemental Appropriations Act of
- 3 2016, Act 124, Session Laws of Hawaii 2016, item C-38.02,
- 4 project adjustment fund, statewide, establishes a contingency
- 5 fund for the airports division project adjustment purposes,
- 6 subject to the provisions of Act 124. However, Act 124, which
- 7 amends Act 119, Session Laws of Hawaii 2015, does not contain a
- 8 budget proviso that permits the utilization of the department of
- 9 transportation, airports division, project adjustment fund. A
- 10 budget proviso relating to the department of transportation,
- 11 airports division, project adjustment fund is necessary to
- 12 authorize the governor to make supplemental allotments from the
- 13 project adjustment fund to supplement any currently authorized
- 14 capital investment cost elements for airports division capital
- 15 improvement projects.

- 1 SECTION 2. Part VII, Act 119, Session Laws of Hawaii 2015,
- 2 as amended by Act 124, Session Laws of Hawaii 2016, is amended
- 3 by adding a new section to read as follows:
- 4 "SECTION . If authorized appropriations specified for
- 5 capital improvement projects listed in this Act or in any other
- 6 act currently authorized by the legislature are insufficient,
- 7 and where the source of funding for the project is designated as
- 8 revenue bond funds, the governor may make supplemental
- 9 allotments from the department of transportation, airports
- 10 division, project adjustment fund appropriated in part II and
- 11 described in part IV of this Act to supplement any currently
- 12 authorized capital investment cost elements; provided that the
- 13 supplemental allotments from the project adjustment fund shall
- 14 not be used to increase the scope of the project; provided
- 15 further that the governor shall submit a report to the
- 16 legislature of all uses of this authority for the previous
- 17 twelve month period from December 1 to November 30 no later than
- 18 thirty days prior to the convening of the regular session of
- 2018."
- 20 SECTION 3. New statutory material is underscored.
- 21 SECTION 4. This Act shall take effect upon its approval.
