A BILL FOR AN ACT

RELATING TO PROHIBITIONS ON UNIVERSITY OF HAWAII PREMISES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds in accordance with 2 article X, section 6, of the state constitution that this Act is 3 of statewide concern. 4 The legislature finds that tobacco use is the single most 5 preventable cause of death in the United States, with tobacco-
- 6 related disease resulting in \$96,000,000,000 in health care
- 7 costs annually. The 2012 United States Surgeon General Report
- 8 states that tobacco use and exposure to second-hand smoke are
- 9 serious public health concerns and that there is no safe level
- 10 of exposure to environmental tobacco smoke.
- 11 Additional concerns have been raised about the growing
- 12 popularity of electronic smoking devices. Sales of electronic
- 13 smoking devices in the United States have doubled each year
- 14 since 2008, with sales in 2013 estimated to have reached
- 15 \$1,700,000,000. Due to the relative lack of research data on
- 16 electronic smoking devices, many public health organizations and
- 17 policymakers are concerned about the safety and impact of these
- 18 products on public health.

1 Smoking and all tobacco use is already prohibited on over seven hundred sixty college and university campuses in the 2 3 United States. Many colleges and universities are including 4 electronic smoking devices in these campus-wide bans. Smoking 5 and tobacco use on the University of Hawaii premises present 6 substantial fiscal burdens for employee health care costs, 7 absenteeism, and turnover; for the maintenance and upkeep of 8 physical facilities; for fire risks and losses; and for litter 9 control, and impose an adverse impact on the surrounding land 10 and water environments. 11 The University of Hawaii's executive policy E10.102 12 prohibits smoking under certain circumstances, but it does not 13 make all of the campuses smoke- and tobacco-free. 14 The purpose of this Act, therefore, is to promote positive 15 health practices and protect University of Hawaii students, **16** employees, and visitors from exposure to second-hand smoke and 17 other potentially harmful substances by prohibiting smoking, 18 including the use of electronic smoking devices, and tobacco use 19 on University of Hawaii premises. 20 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is 21 amended by adding a new section to be appropriately designated 22 and to read as follows: 23 Smoking and tobacco use prohibitions on

University of Hawaii premises. (a) The University of Hawaii

1 shall prohibit smoking and tobacco use by any person on 2 University of Hawaii premises, to the extent that such a 3 prohibition is not prohibited by federal law. Mere possession 4 or storage of cigarettes, tobacco products, or electronic smoking devices for use outside the University of Hawaii 5 6 premises shall not constitute a violation of any policy adopted 7 pursuant to this subsection. 8 (b) This section shall not be subject to chapter 328J. 9 Pursuant to section 89-9(d), the smoking and tobacco use 10 prohibitions under this section shall not be subject to 11 collective bargaining. 12 (c) The University of Hawaii shall be responsible for 13 educating students, employees, and all visitors about the 14 smoking and tobacco use prohibitions under this section. 15 Clearly legible signs shall be prominently displayed stating **16** that "smoking, including the use of electronic smoking devices, **17** and tobacco use are prohibited by law" at all entrances to the 18 premises and at other conspicuous outdoor locations throughout 19 the premises. 20 (d) As used in this section: 21 "Cigarette" has the same meaning as in section 486P-1. 22 "Electronic smoking device" means any electronic product 23 that can be used to aerosolize and deliver nicotine or other

substances to the person inhaling from the device, including but

1 not limited to an electronic cigarette, electronic cigar, 2 electronic cigarillo, electronic pipe, hookah pipe, or hookah 3 pen, and any cartridge or other component of the device or 4 related product, whether or not sold separately. 5 "Premises" means all indoor and outdoor areas within 6 property owned or controlled by the university or for which the 7 university is otherwise responsible. 8 "Smoke" or "smoking" means inhaling, exhaling, burning, or 9 carrying any lighted or heated tobacco product or plant product **10** intended for inhalation in any manner or in any form. "Smoking" 11 includes the use of an electronic smoking device. 12 "Tobacco products" means any products made or derived from 13 tobacco, that contain nicotine or other substances, and are 14 intended for human consumption or are likely to be consumed, 15 whether smoked, heated, chewed, absorbed, dissolved, inhaled, or 16 ingested by any other means, including, but not limited to, a **17** cigarette, cigar, pipe tobacco, chewing tobacco, snuff, snus, or 18 an electronic smoking device. "Tobacco products" do not include 19 drugs, devices, or combination products approved for sale by the 20 United States Food and Drug Administration, as those terms are 21 defined in the Federal Food, Drug, and Cosmetic Act. 22 "Tobacco use" means the personal use of any tobacco

product, including the use of smokeless tobacco."

1 SECTION 3. Section 89-9, Hawaii Revised Statutes, is 2 amended by amending subsection (d) to read as follows: 3 Excluded from the subjects of negotiations are 4 matters of classification, reclassification, benefits of but not 5 contributions to the Hawaii employer-union health benefits trust fund, recruitment, examination, initial pricing, and retirement 6 7 benefits except as provided in section 88-8(h). The employer 8 and the exclusive representative shall not agree to any proposal 9 which would be inconsistent with the merit principle or the **10** principle of equal pay for equal work pursuant to section 76-1 11 or which would interfere with the rights and obligations of a 12 public employer to: 13 (1) Direct employees; 14 Determine qualifications, standards for work, and the (2) 15 nature and contents of examinations; **16** Hire, promote, transfer, assign, and retain employees (3) **17** in positions; 18 (4)Suspend, demote, discharge, or take other disciplinary 19 action against employees for proper cause; 20 (5) Relieve an employee from duties because of lack of 21 work or other legitimate reason; 22 (6) Maintain efficiency and productivity, including 23 maximizing the use of advanced technology, in 24 government operations;

TITLE: A BILL FOR AN ACT RELATING TO PROHIBITIONS

ON UNIVERSITY OF HAWAII PREMISES.

PURPOSE: Prohibits smoking and tobacco use, including

the use of electronic smoking devices, on

University of Hawaii premises.

MEANS: Add a new section to chapter 304A, Hawaii

Revised Statutes (HRS), and amend section

89-9(d), HRS.

JUSTIFICATION: Tobacco use is the single most preventable

cause of death in the United States, with tobacco-related disease resulting in \$96,000,000,000 in health care costs annually. The 2012 United States Surgeon General Report states that tobacco use and exposure to secondhand smoke are serious public health concerns and that there is no

safe level of exposure to environmental

tobacco smoke.

The legislature has recognized through the years that smoking and secondhand smoke exposure are major contributors to many health problems and has imposed smoking restrictions within state facilities. Counties in Hawaii have also addressed at varying levels the concern over smoking in public areas. To address these varying levels of protection within ordinances adopted by counties in Hawaii, Act 295 was passed in 2006 to create a new chapter (chapter 328J, HRS) ensuring a consistent level of basic protections statewide from exposure to secondhand smoke and expanding the scope of smoke free prohibitions in various enclosed and partially enclosed areas. Act 87, Session Laws of Hawaii (SLH) 2004, imposed a smoking ban on employees in

all Hawaii public schools and at public school functions, with certain exceptions. These exceptions were later removed by Act 232, SLH 2014, which imposed a complete ban on smoking at all K-12 public schools and public school functions in the state. Act 91, SLH 2014, prohibited smoking in and around public housing projects. Act 123, SLH 2015, prohibited smoking and the use of tobacco products and excigarettes within the state park system. And in 2015, via Act 122, Hawaii became the first state in the nation to raise the legal smoking age to 21.

According to the University of Hawaii's Institutional Research and Analysis Office, during the Fall 2015 semester, approximately 40 percent of the total students enrolled or 20,627 in the UH system were under the age of 21.

Allowing smoking and tobacco use on the University of Hawaii premises both presents substantial fiscal burdens for employee health care costs, absenteeism, and turnover; the maintenance and upkeep of physical facilities; fire risks and losses; and litter control as well as imposes an adverse impact on the surrounding land and water environments.

The University of Hawaii's executive policy E10.102 prohibits smoking under certain circumstances, but it does not make all of the campuses smoke- and tobacco-free.

Additionally, concerns have been raised about the growing popularity of electronic smoking devices among our youth. Due to the relative lack of research data on electronic smoking devices, many public health organizations and policymakers are concerned about the safety and impact of these products on public health.

The purpose of this Act is to promote positive health practices and protect

University of Hawaii students, employees, and visitors from exposure to secondhand smoke and other potentially harmful substances by prohibiting smoking, including the use of electronic smoking devices, and tobacco use on University of Hawaii premises.

Impact on the public: The University of Hawaii sees the health and safety of our faculty, staff, and students, as well as visitors to each of our 10 campuses, to be paramount. As mentioned above, tobacco use and exposure to secondhand smoke are serious public health concerns and there is no safe level of exposure to environmental tobacco smoke.
