### A BILL FOR AN ACT

PART I

RELATING TO RECORDS MANAGEMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. The legislature finds that the department of
3	education is required to maintain student records as evidence of
4	activities, transactions, and decisions that show the existence
5	and validity of student attendance in school. However, as the
6	State currently has no uniform requirement for the retention of
7	student records, schools vary in the length of time they store
8	and maintain them.
9	The legislature further finds that other states require
10	student records to be stored and maintained anywhere from sixty
11	to one hundred years, with many states requiring that student
12	records be stored and maintained permanently.
13	The purpose of this part is to require the department of
14	education to store student records for a period of not less than
15	one hundred years following the graduation, transfer, or
16	separation from the department of the student.

1	SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§302A- Retention of student records. (a) Student
5	records may be digitized, computerized, or minified through the
6	use of scanning equipment or any other similar digitization
7	process or microfilm or any other similar photographic process;
8	provided that the method used creates an unalterable record.
9	(b) Student records shall be retained in the original or
10	reproduced form for a minimum of one hundred years following the
11	student's transfer, graduation, or other separation from the
12	department.
13	(c) Student records may be destroyed after the retention
. 14	period specified in subsection (b) or upon digitization,
15	computerization, or minification, in a manner that preserves the
16	confidentiality of the information in the record.
17	(d) As used in this section, "student records" means any
18	official student document as determined by the department and in
19	accordance with state and federal law."
20	PART II

1 SECTION 3. The legislature finds that schools currently 2 store student records in accordance with their individual resources, which may include non-fireproof, locked file cabinets 3 or on-site containers. This varied filing maintenance and 4 5 storage system is inefficient and makes document retrieval difficult and time consuming. In addition, it increases the 6 7 risk of misplaced or misfiled records, which can result in even 8 greater delays in response to requests for such records. 9 The legislature further finds that there is a critical need 10 to modernize the student record management systems in the 11 department of education. While some schools have used their 12 weighted student formula funds to invest in digitizing student 13 records for more reliable storage and efficient document 14 management and retrieval, those schools that are not able to set 15 aside funds for digitization must continue to waste space and 16 resources for the storage of paper records. 17 The legislature additionally finds that the Hawaii 18 correctional industries program has begun a new digitization 19 program, using modern tools and equipment, including high speed 20 scanners, optical character recognition software, and electronic 21 document management systems, intended to assist state agencies

- 1 in modernizing their record management systems and provide
- 2 skills training and development for inmates. A partnership
- 3 between the department of education and the Hawaii correctional
- 4 industries program would benefit state agencies and the
- 5 populations they serve.
- 6 The purpose of this part is to authorize the department of
- 7 education to partner with the Hawaii correctional industries
- 8 program in a student records modernization pilot project and to
- 9 appropriate funds for this purpose.
- 10 SECTION 4. (a) The department of education may partner
- 11 with the Hawaii correctional industries program to engage in a
- 12 three-year student records modernization pilot project. Any
- 13 pilot project conducted pursuant to this section shall include:
- 14 (1) One elementary school;
- 15 (2) One middle or intermediate school; and
- 16 (3) One high school,
- 17 in each county.
- 18 (b) The department of education shall submit a report on
- 19 the status of any pilot project conducted pursuant to subsection
- 20 (a), including any findings, recommendations, and proposed
- 21 legislation, to the legislature no later than twenty days prior

- 1 to the convening of the regular sessions of 2018, 2019, and 2 2020. 3 SECTION 5. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 4 or so 5 much thereof as may be necessary for fiscal year 2017-2018 and 6 the same sum or so much thereof as may be necessary for fiscal 7 year 2018-2019 for a pilot project to modernize student records 8 management systems within the department of education. 9 The sums appropriated shall be expended by the department 10 of education for the purposes of this Act. 11 PART III 12 SECTION 6. New statutory material is underscored.

  - SECTION 7. This Act shall take effect upon its approval;
- 14 provided that part II of this Act shall take effect on July 1,
