A BILL FOR AN ACT

RELATING TO THE STATE OF GOA, REPUBLIC OF INDIA.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature established a sister-state
- 2 relationship between the State of Hawaii and the State of Goa,
- 3 Republic of India through the adoption of Senate Concurrent
- 4 Resolution No. 20, S.D. 1, H.D. 1 (2016).
- 5 The purpose of this Act is to appropriate funds to the
- 6 department of business, economic development, and tourism for
- 7 the establishment of a State of Hawaii sister-state office in
- 8 the State of Goa, Republic of India.
- 9 SECTION 2. There is appropriated out of the general
- 10 revenues of the State of Hawaii the sum of \$250,000 or so much
- 11 thereof as may be necessary for fiscal year 2017-2018 and the
- 12 same sum or so much thereof as may be necessary for fiscal year
- 13 2018-2019 for the department of business, economic development,
- 14 and tourism to establish a State of Hawaii sister-state office
- in the State of Goa, Republic of India.
- 16 The sums appropriated shall be expended by the department
- 17 of business, economic development, and tourism for the purposes
- 18 of this Act.

- 1 SECTION 3. At least twenty days prior to the convening of
- 2 the 2018 regular session of the legislature, the department of
- 3 business, economic development, and tourism shall submit a
- 4 report detailing trade, economic development, business
- 5 partnerships, cultural exchange, and educational exchange in the
- 6 Republic of India, and specific to the State of Goa, and between
- 7 the State of Goa and the State of Hawaii. The purpose of the
- 8 report shall be to detail the existing state of and potential
- 9 growth in trade, economic development, business partnerships,
- 10 cultural exchange, and educational exchange in the Republic of
- 11 India and the State of Goa, and between the State of Goa and
- 12 Hawaii.
- 13 SECTION 4. This Act shall take effect on July 1, 2017.
