A BILL FOR AN ACT

RELATING TO PUBLIC UTILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the public order is 2 threatened if illegal occupants on real property may have 3 electric power connections installed upon the property or have 4 an account or service transferred to a power connection on 5 illegally occupied property. 6 The purpose of this Act is to ensure that only legal 7 occupants on real property may have an electric power connection 8 installed upon the premises or have an account or service 9 transferred to that power connection.

SECTION 2. Chapter 269, Hawaii Revised Statutes, is amended by adding a new section to part I to be appropriately designated and to read as follows:

13 "§269- Installation; transfers; prohibited; when. (a)
14 No electric utility may install a power connection or transfer
15 the account or service associated with that power connection
16 unless the electric utility obtains written and notarized

2		authorized agent of record, to perform the

4	(2)	From the occupant of the premises upon which is
5		installed the power connection, to transfer the
6		account or service associated with that power

8	(b)	If the occupant of the premises is not the owner of
9	record, or the authorized agent of record, the written and	
10	notarized	authorization shall describe the nature of the
11	occupant'	s tenancy on the premises that has a power connection
12	installed	upon it. The types of tenancies described in the
13	authoriza	tion may include the types of arrangements covered
14	under the residential landlord-tenant code, including rental	
15	agreement	s, subleases, or assignments.
16	(c) Subsection (a)(2) shall not apply if an account or	
17	service i	s being restarted in the name of the holder of that
18	account o	r service following a power disconnection due to the
19	nonpaymen	t by the holder of that account."
