PART I

2 SECTION 1. The purpose of this Act is to ensure a more 3 democratic election process for the office of Hawaiian affairs 4 by amending the election process for the four at-large seats for the office of Hawaiian affairs board of trustees so that each of 5 6 the four at-large seat candidates is required to be a resident 7 of an urban or rural district and run in a head-to-head race. 8 SECTION 2. Chapter 13D, Hawaii Revised Statutes, is 9 amended by adding a new section to be appropriately designated 10 and to read as follows: 11 "§13D-**Definitions.** For the purposes of this chapter,

12 unless the context requires otherwise:

13 <u>"Rural district" means the second congressional district of</u>
14 the State.

15 <u>"Urban district" means the first congressional district of</u>
16 <u>the State.</u>"

Of the three members who are elected to an at-10 large seat without a residency requirement for the board of 11 trustees of the office of Hawaiian affairs in the general 12 election of 2018, the member who receives the lowest number of 13 votes shall serve a term of two years. If one or more members 14 are elected at the primary election of 2018, then the board of 15 trustees of the office of Hawaiian affairs shall select amongst 16 the newly elected members one member to serve a term of two 17 years; provided that after the general election of 2020, all 18 members shall serve a term of four years. 19 PART III 20 SECTION 9. Report Title: OHA At-large-Positions; Election

Description:

Requires two at-large seats to reside in an urban district and two at-large seats to reside in a rural district. Requires one urban district candidate and one rural district candidate to be elected in any election cycle. Changes the term of the member who receives the lowest number of votes in the 2018 general election to serve a term of two years and a term of four years after the general election of 2020. Takes effect upon approval; provided that part I shall take effect on January 1, 2020. (SD1)
