A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 157, Hawaii Revised Statutes, is
2	amended b	y adding a new section to be appropriately designated
3	and to re	ad as follows:
4	" <u>§15</u>	7- Raw milk; pet use. (a) The acquisition of raw
5	milk or r	aw milk products by a consumer shall not be prohibited
6	if the fo	llowing conditions are met:
7	(1)	The consumer is an owner of a pet animal and acquires
8		raw milk or raw milk products directly from a farm or
9		dairy that is registered pursuant to subsection (b);
10	(2)	A prominent disclaimer that the raw milk or raw milk
11		products are intended solely for consumption by pet
12		animals and not for human consumption is displayed on
13		a label affixed to the container; and
14	(3)	A prominent warning statement that the raw milk or raw
15		milk products are not pasteurized is delivered to the
16		consumer with the raw milk or raw milk products or is
17		displayed on a label affixed to the container.

1	(b) Farms or dairies that provide raw milk or raw milk	
2	products to consumers shall register with the State by	
3	delivering to the department of health a written statement	
4	containing:	
5	(1) The name of the farm or dairy;	
6	(2) A valid, current address of the farm or dairy; and	
7	(3) A statement that raw milk or raw milk products are	
8	being produced at the farm or dairy.	
9	(c) No person who, as a consumer, acquires raw milk or raw	
10	milk products, in accordance with this section, shall be	
11	entitled to sell or redistribute raw milk or raw milk products.	
12	(d) No producer of raw milk or raw milk products shall	
13	publish any statement that implies approval or endorsement of	
14	raw milk or raw milk products by the department of health.	
15	(e) For the purposes of this section, unless the context	
16	clearly indicates otherwise:	
17	"Pet animal" means any animal that has commonly been kept	
18	as a pet in family households such as dogs, cats, guinea pigs,	
19	rabbits, and hamsters. "Pet animal" does not include exotic	
20	animals or wild animals.	

1	"Raw milk" means the lacteal secretion that comes straight		
2	out of a mammal and has not been pasteurized or homogenized.		
3	"Raw milk products" means any food that contains raw milk		
4	and shall include but not be limited to butter, cheese, cottage		
5	cheese, cream, and kefir."		
6	SECTION 2. Section 157-21, Hawaii Revised Statutes, is		
7	amended to read as follows:		
8	"§157-21 Licensing. [#t] Except as provided in section		
9	157- , it shall be unlawful for any producer, producer-		
10	distributor, or distributor to produce, sell, process, or		
11	distribute milk in a milk shed unless the person is duly		
12	licensed as provided by this chapter. It shall be unlawful for		
13	any such person to sell, buy, process, or distribute milk which		
14	the person knows or has reason to believe has been produced or		
15	handled in violation of this chapter."		
16	SECTION 3. Statutory material to be repealed is bracketed		
17	and stricken. New statutory material is underscored.		
18	SECTION 4. This Act shall take effect upon its approval.

Raw Milk; Raw Milk Products; Pet Animal; Agriculture

Requires farms and dairies that produce raw milk or raw milk products to register with the department of health.
