A BILL FOR AN ACT

RELATING TO DRUG TREATMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that opioid addiction is
- 2 a growing problem in Hawaii. According to data from the federal
- 3 Centers for Disease Control and Prevention, drug overdose deaths
- 4 in Hawaii have increased by eighty-three per cent from 2006 to
- 5 2014, a growth rate more than double the national average, and a
- 6 majority of those deaths are a result of prescription opioids
- 7 and heroin.
- 8 The legislature finds that methamphetamine abuse and
- 9 addiction are also a growing problem in Hawaii. According to
- 10 the United States Sentencing Commission, methamphetamine plays a
- 11 role in over ninety per cent of drug convictions, more than
- 12 triple the national average.
- 13 Drug treatment has been found to be a cost-effective way to
- 14 reduce drug abuse. Money spent on drug treatment saves on law
- 15 enforcement costs, crime costs, prison costs, and homelessness.
- 16 Drug treatment is more cost effective than law enforcement,

- interdiction, and source control, due to lower costs per 1
- 2 offender and lower recidivism rates.
- The purpose of this Act is to appropriate funds for 3
- providing drug treatment to drug abusers. 4
- SECTION 2. There is appropriated out of the general 5
- 6 revenues of the State of Hawaii the sum of \$1,000,000 or so much
- thereof as may be necessary for fiscal year 2018-2019 for the 7
- department of health to contract with outside vendors, 8
- 9 contractors, and healthcare providers to provide drug treatment,
- 10 to be allocated as follows:
- 11 \$250,000 to treat opioid abuse; (1)
- 12 \$250,000 to treat methamphetamine abuse; (2)
- 13 (3) \$200,000 to treat heroin abuse;
- (4) \$150,000 to treat prescription drug abuse; and 14
- 15 \$150,000 to treat other drug abuse. (5)
- 16 The sum appropriated shall be expended by the department of
- 17 health for the purposes of this Act.
- 18 SECTION 3. This Act shall take effect on July 1, 2018.
