BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 356D, Hawaii Revised Statutes, is 2 amended by adding a new part to be appropriately designated and
- 4 "PART . HOUSING SUPPORT PROGRAM
- 5 §356D-A Definitions. As used in this part:
- 6 "Participating landlord" means a property owner or property
- 7 manager who has entered an agreement with the authority to
- 8 participate in the housing support program and offer rental
- 9 housing units to eligible individuals or families.
- 10 "Participating unit" means a rental housing unit that has
- 11 been designated by a participating landlord for occupancy by an
- 12 eligible individual or family.
- 13 §356D-B Housing support program; established. (a) There
- 14 is established within the authority a housing support program
- 15 that shall provide housing support payments to participating
- 16 landlords on behalf of persons or families who meet the
- 17 eligibility requirements provided in section 356D-C.

- 1 (b) The authority shall establish rules pursuant to
- 2 chapter 91 for the purpose of implementing this part.
- 3 §356D-C Eligibility for housing support payment. (a) A
- 4 person or family is eligible for housing support payments if
- 5 that person or family:
- 6 (1) Meets the definition of "qualified tenant" under
- 7 section 356D-153 and does not own personal property
- 8 and assets in excess of \$10,000; or
- 9 (2) Is a participant in a housing first program or service
- established pursuant to section 346-378.
- 11 (b) The authority shall conduct annual eligibility
- 12 evaluations of all persons or families who are receiving housing
- 13 support payments.
- (c) Notwithstanding any law to the contrary, income from
- 15 other state or federal need-based benefit programs shall not be
- 16 included in any calculation to determine eligibility for housing
- 17 support payments.
- (d) The authority shall evaluate the eligibility of a
- 19 person or family before making housing benefit payments on
- 20 behalf of that person or family. The eliqibility of a person or

1 family who is receiving housing support payment benefits shall 2 be reevaluated at least once every twelve months. 3 §356D-D Housing support payments; monthly rates. 4 authority shall negotiate monthly housing support payment rates 5 with participating landlords; provided that rates shall not 6 exceed the total of: 7 (1) Sixty per cent of the federal poverty level, divided 8 by twelve and rounding down the quotient, for a family with a number of members equal to the intended 9 10 occupancy of the participating unit; and (2) The maximum allotment authorized by the federal 11 Supplemental Nutrition Assistance Program for a single 12 13 individual that is in effect on the first day of July 14 each year. 15 The authority shall make housing support payments to

- 1 §356D-E Housing support program special fund. There is
- 2 established in the state treasury the housing support program
- 3 special fund to be administered by the authority and into which
- 4 shall be deposited appropriations made by the legislature to the
- 5 special fund. Moneys in the special fund shall be used for the
- 6 purpose of making housing support payments pursuant to this
- 7 part."
- 8 SECTION 2. The Hawaii public housing authority shall
- 9 develop interim rules without regard to chapter 91, Hawaii
- 10 Revised Statutes, for assisting participants in the housing
- 11 support program pursuant to section 1 of this Act.
- 12 SECTION 3. The Hawaii public housing authority may procure
- 13 case management and counseling services without regard to
- 14 chapters 103D and 103F, Hawaii Revised Statutes, for assisting
- 15 participants in the housing support program pursuant to section
- 16 1 of this Act.
- 17 SECTION 4. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$ or so
- 19 much thereof as may be necessary for fiscal year 2018-2019 to be
- 20 deposited into the housing support program special fund.

- 1 SECTION 5. There is appropriated out of the housing
- 2 support program special fund the sum of \$ or so much
- 3 thereof as may be necessary for fiscal year 2018-2019 for the
- 4 housing support program to make housing support payments on
- 5 behalf of eligible persons and families.
- 6 The sum appropriated shall be expended by the Hawaii public
- 7 housing authority for the purposes of this Act.
- 8 SECTION 6. This Act shall take effect on July 1, 2018.
