### A BILL FOR AN ACT

RELATING TO APPROPRIATIONS TO ADDRESS HOMELESSNESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the coordinated
- 2 statewide homeless initiative provides important, cost-effective
- 3 homelessness prevention and rapid rehousing services statewide
- 4 and increases coordination through the statewide information and
- 5 referral system on behalf of homeless individuals and those at
- 6 risk of homelessness.
- 7 The coordinated statewide homeless initiative originated in
- 8 April 2016 to help hundreds of families escape or avoid
- 9 homelessness. According to Aloha United Way, since the program
- 10 began, the program has helped more than fourteen hundred
- 11 households comprising four thousand eight hundred individuals.
- 12 About three-quarters of households had been at risk of losing
- 13 housing and the rest were already homeless. Of these numbers,
- 14 sixty-four per cent included children.
- 15 Accordingly, the purpose of this Act is to appropriate
- 16 moneys to continue and improve the coordinated statewide

3	SECTION 2. (a) There is appropriated out of the general				
4	revenues of the State of Hawaii the sum of \$2,500,000 or so much				
5	thereof as may be necessary for fiscal year 2018-2019 to

20	103D or 103F, Hawaii Revised Statutes;				

1		(B)	Have oversight or manage the funds expended by
2			the master contractor; and
3		(C)	Develop policies and procedures for a fair and
4			equitable procurement process consistent with the
5			goals of public accountability and public
6			procurement practices;
7	(2)	The	master contractor shall:
8		(A)	Operate a coalition of agencies providing
9			homeless diversion services for the State by
10			providing short-term financial assistance to
11			households that have entered the eviction
12			process;
13		(B)	Coordinate with the coordinated entry system
14			mandated by the United States Department of
15			Housing and Urban Development to provide
16			navigation services and placement of homeless
17			households into permanent housing;
18		(C)	At a minimum, provide quarterly reports to the
19			house of representatives and senate committees on
20			housing and human services respectively.

1		(D) Develop reporting procedures and timelines for
2		providing performance information to respective
3		state agencies; and
4		(E) Be accountable for funds expended;
5	(3)	The master contractor may retain administrative fees
6		of fifteen per cent in total from the amounts paid
7		under the master contract between the master
8		contractor and subcontractors; and
9	(4)	The total sum of funding shall be provided at the
10		start of the coordinated statewide homeless initiative
11		program to be managed by the master contractor;
12		provided that the administration of such funds shall
13		conform to accepted industry financial accounting and
