A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State is
- 2 obligated to meet its mandate to conserve agricultural land
- 3 pursuant to article XI, section 3, of the Hawaii State
- 4 Constitution, which requires the State to conserve and protect
- 5 agricultural lands, promote diversified agriculture, increase
- 6 agricultural self-sufficiency, and assure the availability of
- 7 agriculturally suitable lands. The legislature further finds
- 8 that the State must take a more active role in providing
- 9 assistance to promote farming as a business.
- 10 The legislature further finds that over the past four
- 11 decades, there has been a steady decline of agricultural
- 12 plantations in Hawaii. A report issued by the department of
- 13 agriculture, entitled "Statewide Agricultural Land Use Baseline
- 14 2015" (report), shows a dramatic change in agricultural land
- 15 over the last thirty-five years as sugar and pineapple
- 16 production have downsized. According to the report, in 2015,
- 17 Hawaii had approximately 151,830 acres of agricultural land in



- 1 active crop production and 761,430 acres in pasture use,
- 2 compared to approximately 350,830 acres in cropland and
- 3 1,100,000 acres in pasture use in 1980.
- 4 The legislature further finds that large tracts of
- 5 agricultural land identified by the office of planning are now
- 6 fallow, including those formerly used for pineapple and sugar
- 7 cane. These lands provide a unique opportunity for the State to
- 8 fulfill the intent of its constitutional mandate regarding
- 9 diversified agriculture and agricultural self-sufficiency
- 10 through acquisition of suitable agricultural land for long-term
- 11 leases for diversified and bona fide agricultural operations
- 12 that increase agricultural production.
- A separate report by the office of planning, in cooperation
- 14 with the department of agriculture, entitled "Increased Food
- 15 Security and Food Self-Sufficiency Strategy", recommends that
- 16 the State acquire and manage agricultural lands to strengthen
- 17 the local food system.
- 18 The legislature further finds that attempts to stimulate
- 19 diversified agriculture in the private sector through regulatory
- 20 controls and land use and zoning restrictions are not sufficient
- 21 to address the business needs necessary to effectively and

- 1 significantly increase diversified agriculture and avert
- 2 Hawaii's agricultural self-sufficiency crisis. Furthermore,
- 3 programs to preserve the remaining agricultural lands, such as
- 4 important agricultural lands, do not prevent subdivision or
- 5 condominium property regimes.
- 6 The legislature further finds that the governor has
- 7 committed to double Hawaii's food production by 2020. To
- 8 accomplish that objective, the governor aims to make more land
- 9 available for agriculture as a priority.
- 10 The purpose of this Act is to:
- 11 (1) Establish the agricultural land acquisition fund for
- the acquisition, administration, maintenance, and
- management of agricultural lands and irrigation
- 14 systems to improve food security; and
- 15 (2) Make appropriations into and out of the agricultural
- land acquisition fund.
- 17 SECTION 2. Chapter 163D, Hawaii Revised Statutes, is
- 18 amended by adding a new section to part I to be appropriately
- 19 designated and to read as follows:
- 20 "§163D- Agricultural land acquisition fund. (a) There
- 21 is established within the state treasury the agricultural land

acquisition fund to be administered by the corporation and into 1 2 which shall be deposited: 3 (1) Legislative appropriations; 4 (2) Environmental response, energy, and food security tax 5 revenues pursuant to section 243-3.5; and Funds from other sources, including gifts, donations, 6 (3) 7 and grants from public agencies and private persons or 8 entities. 9 Moneys in the agricultural land acquisition fund shall **10** be expended for the acquisition, administration, maintenance, 11 and management of agricultural lands and irrigation systems to 12 improve food security." 13 SECTION 3. Section 243-3.5, Hawaii Revised Statutes, is 14 amended by amending subsections (a) and (b) to read as follows: 15 In addition to any other taxes provided by law, **16** subject to the exemptions set forth in section 243-7, there is **17** hereby imposed a state environmental response, energy, and food 18 security tax on each barrel or fractional part of a barrel of 19 petroleum product sold by a distributor to any retail dealer or 20 end user of petroleum product, other than a refiner. The tax shall be \$1.05 on each barrel or fractional part of a barrel of 21

3	(1)	5 cents of the tax on each barrel shall be deposited
4		into the environmental response revolving fund

9	(3)	10 cents of the tax on each barrel shall be deposited
10		into the energy systems development special fund
11		established under section 304A-2169.1; [and]
12	(4)	15 cents of the tax on each barrel shall be deposited
13		into the agricultural development and food security
14		special fund established under section 141-10[+]; and
15	(5)	cents of the tax on each barrel shall be
16		deposited into the agricultural land acquisition fund
17		established under section 163D
18	The	tax imposed by this subsection shall be paid by the

20	(b)	In addition to subsection (a), the tax shall also be

7	SECTION 4. There is appropriated out of the general		
8	revenues of the State of Hawaii the sum of \$ or so much		
9	thereof as may be necessary for fiscal year 2018-2019 for		
10	deposit into the agricultural land acquisition fund established		
11	under section 163D- , Hawaii Revised Statutes.		
12	SECTION 5. There is appropriated out of the agricultural		
13	land acquisition fund the sum of \$ or so much thereof as		
14	may be necessary for fiscal year 2018-2019 for the acquisition,		
15	administration, maintenance, and management of agricultural		
16	lands and irrigation systems to improve food security.		
17	The sum appropriated shall be expended by the agribusiness		
18	development corporation for the purposes of this Act.		
19	SECTION 6. Statutory material to be repealed is bracketed		
20	and stricken. New statutory material is underscored.		
21	SECTION 7. This Act shall take effect on July 31, 2150.
