4 revenues of the State of Hawaii the sum of \$ or so much
5 thereof as may be necessary for fiscal year 2018-2019 for the
6 agribusiness development corporation to award grants for
7 agriculture-related improvements to existing and emerging farms
8 and agribusiness operations.

9 The sum appropriated shall be expended by the agribusiness10 development corporation for the purposes of this Act.

SECTION 5. Statutory material to be repealed is bracketedand stricken. New statutory material is underscored.

13 SECTION 6. This Act shall take effect on July 1, 2150.
