# A BILL FOR AN ACT

RELATING TO COFFEE BERRY BORER.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 105, Session Laws of Hawaii 2014,
- 2 established a pesticide subsidy program in the department of
- 3 agriculture for five years to assist coffee growers with
- 4 offsetting the costs of purchasing certain pesticides known to
- 5 be effective against the coffee berry borer, a highly
- 6 destructive coffee pest that has infested coffee crops on the
- 7 island of Hawaii, and more recently has been detected on the
- 8 islands of Oahu and Maui.
- 9 Act 152, Session Laws of Hawaii 2015, established a
- 10 pesticide subsidy program manager position as a full-time,
- 11 temporary position exempt from chapters 76 and 89, Hawaii
- 12 Revised Statutes. Section 76-16(b)(17), Hawaii Revised
- 13 Statutes, provides that any exemption created after July 1,
- 14 2014, shall expire three years after its enactment unless
- 15 affirmatively extended by an act of the legislature. Pursuant
- 16 to section 76-16(b)(17), Hawaii Revised Statutes, the exemption
- 17 from civil service and collective bargaining laws of the

- 1 pesticide subsidy program manager position will expire on
- 2 June 30, 2018, three years after it was created by Act 152,
- 3 Session Laws of Hawaii 2015.
- 4 Because it took longer than anticipated for Act 105 to be
- 5 implemented, Act 65, Session Laws of Hawaii 2017, extended the
- 6 pesticide subsidy program from its original sunset date of
- 7 June 30, 2019, to a new sunset date of June 30, 2021, to assist
- 8 coffee growers for the number of years intended when Act 105,
- 9 Session Laws of Hawaii 2014, was enacted. However, Act 65,
- 10 Session Laws of Hawaii 2017, did not extend the civil service
- 11 and collective bargaining laws exemption of the pesticide
- 12 subsidy program manager position.
- 13 Pursuant to section 3(c) of Act 105, Session Laws of Hawaii
- 14 2014, an application for a subsidy for pesticide purchases made
- 15 in a fiscal year must be filed in the immediately following
- 16 fiscal year. For pesticide purchases made in the last fiscal
- 17 year of the program, from July 1, 2020, to June 30, 2021,
- 18 applications for subsidies must be filed in the immediately
- 19 following fiscal year, anytime from July 1, 2021, to June 30,
- 20 2022. The manager position will be needed to process these

- 1 applications for subsidies for costs incurred in the final year
- 2 of the program.
- 3 Accordingly, the purpose of this Act is to extend the
- 4 pesticide subsidy program manager position through the fiscal
- 5 year immediately following the program sunset date in order to
- 6 process applications for subsidies for costs incurred in the
- 7 final year of the program and affirmatively extend the civil
- 8 service and collective bargaining laws exemption of the program
- 9 manager position.
- 10 SECTION 2. Section 3 of Act 105, Session Laws of Hawaii
- 11 2014, as amended by Section 1 of Act 152, Session Laws of Hawaii
- 12 2015, as amended by Section 2 of Act 65, Session Laws of Hawaii
- 13 2017, is amended by amending subsection (g) to read as follows:
- "(g) There is established within the department a
- 15 pesticide subsidy program manager position, which shall be a
- 16 full-time, temporary position exempt from chapters 76 and 89,
- 17 Hawaii Revised Statutes. The pesticide subsidy program manager
- 18 shall possess a requisite level of knowledge and expertise in
- 19 the area of program management necessary to carry out the duties
- 20 of the position. The pesticide subsidy program manager shall:

5	The pesticide subsidy program manager shall receive a salary o

8	chapters	76 and 89, Hawaii Revised Statutes, shall expire on
9	June 30,	2022."
10	SECT	ION 3. New statutory material is underscored.

SECTION 4. This Act shall take effect on July 1, 2050.

#### Report Title:
