A BILL FOR AN ACT

RELATING TO PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 103D, Hawaii Revised Statutes, is
2	amended by adding a new section to part IV to be appropriately
3	designated and to read as follows:
4	"§103D- Single-serving plastic beverage containers;
5	prohibition on using state funds to purchase. (a)
6	Notwithstanding sections 103D-102(b)(3), (b)(4)(H), and
7	(b)(4)(L) and 103D-305 to the contrary, no state agency shall
8	use state funds for the purchase of beverages in plastic bottles
9	or rigid plastic containers, except as provided in subsection
10	(b).
11	(b) The following circumstances shall constitute
12	exceptions to subsection (a):
13	(1) Public health and safety preparedness, emergencies,
14	investigations, and extended deployments or
15	activations of the office of hazard evaluation and
16	emergency response of the department of health or the
17	department of defense;

1	(2)	Situations where there is high risk of cross-	
2		contamination with non-potable or contaminated water;

14	<u>"Sta</u>	te agency" means a department, division, agency,	
15	office, b	oard, commission, bureau, or council of the State.	
16	"State funds" means any money deposited into or drawn from		
17	the state	treasury or any special or trust fund of the State.	
18	"State funds" includes any money appropriated by the State and		
19	transferred to any state agency that is used by the state		
20	agency, in whole or in part, to purchase goods or services."
