### A BILL FOR AN ACT

RELATING TO THE STATEWIDE TRAFFIC CODE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that secondhand smoke is
- 2 a dangerous class A carcinogen, in the same class as asbestos
- 3 and benzene. Secondhand smoke typically contains at least seven
- 4 thousand identifiable chemicals, around seventy of which are
- 5 known or probable carcinogens. The fiftieth anniversary United
- 6 States Surgeon General Report, released on January 17, 2014,
- 7 states that any level of exposure to secondhand smoke is
- 8 dangerous and over two and a half million nonsmokers have died
- 9 from health problems caused by secondhand smoke since 1964.
- 10 Secondhand smoke can cause heart disease, lung cancer, and
- 11 strokes, according to the Centers for Disease Control and
- 12 Prevention.
- 13 The legislature further finds that children run a greater
- 14 risk of suffering from the damaging health effects of secondhand
- 15 smoke because children have a higher exposure risk and are
- 16 susceptible to more health problems. Children have a higher
- 17 exposure risk to secondhand smoke: children generally breathe in



- 1 more air than adults because their lungs are still developing,
- 2 and they have little or no control over their environments and
- 3 cannot leave if secondhand smoke bothers them. Children exposed
- 4 to secondhand smoke face additional health consequences: ear
- 5 infections; more frequent and severe asthma attacks; respiratory
- 6 symptoms such as coughing, sneezing, and shortness of breath;
- 7 respiratory infections such as bronchitis and pneumonia; and
- 8 increased risk of sudden infant death syndrome. This means that
- 9 smoke-free environments for children is of high importance.
- 10 Studies have found that secondhand smoke exposure in
- 11 vehicles is more concentrated than in bars and restaurants.
- 12 Secondhand smoke in a car causes the air to be many times more
- 13 toxic than what the Environmental Protection Agency considers
- 14 hazardous air quality, even when a window is down. Smoke-free
- 15 vehicle policies ensure that there is clean air in the vehicle
- 16 while a child is inside.
- 17 According to the Campaign for Tobacco-Free Kids, as of
- 18 April 2016, the states of Arkansas, California, Louisiana,
- 19 Maine, Oregon, Utah, Vermont, and Virginia, as well as Puerto
- 20 Rico, have enacted smoke-free vehicle laws to protect minors.
- 21 In addition, section 14-21(a)(12) of the Hawaii County Code



- 1 prohibits smoking in any motor vehicle whenever occupied by a
- 2 person less than eighteen years of age.
- 3 The purpose of this Act is to amend state law to prohibit
- 4 smoking in a motor vehicle when a minor is present.
- 5 SECTION 2. Chapter 291C, Hawaii Revised Statutes, is
- 6 amended by adding a new section to part XII to be appropriately
- 7 designated and to read as follows:
- 8 "§291C- Smoking in a motor vehicle in which a minor is
- 9 present; prohibited. (a) No person shall smoke in a motor
- 10 vehicle in which a person under the age of eighteen is present.
- 11 (b) For the purposes of this section, "smoke" shall have
- 12 the same meaning as provided in section 328J-1.
- (c) Any person who violates this section shall be fined
- 14 \$100."
- 15 SECTION 3. Section 291C-161, Hawaii Revised Statutes, is
- 16 amended by amending subsection (c) to read as follows:
- 17 "(c) Every person convicted under or found in violation of
- 18 section 291C-12, 291C-12.5, 291C-12.6, 291C-13, 291C-14,
- 19 291C-15, 291C-16, 291C-72, 291C-73, 291C-95, 291C-102, 291C-103,
- 20 291C-104, [or] 291C-105, or 291C- shall be sentenced or fined
- 21 in accordance with those sections."

- 1 SECTION 4. The department of health shall submit a report
- 2 to the legislature regarding the enforceability of this Act and
- 3 coordination of related data collection efforts of the
- 4 respective law enforcement agencies, including any proposed
- 5 legislation, no later than twenty days prior to the convening of
- 6 the regular session of 2020.
- 7 SECTION 5. This Act does not affect rights and duties that
- 8 matured, penalties that were incurred, and proceedings that were
- 9 begun before its effective date.
- 10 SECTION 6. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 7. This Act shall take effect upon its approval.
