# A BILL FOR AN ACT

---

RELATING TO BOARDS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The legislature finds that several boards in  
2       Hawaii have the word "examiners" in their name although they no  
3       longer administer exams. The purpose of this Act is to more  
4       accurately reflect the scope and duties of certain boards by  
5       removing the word "examiners" from the state board of  
6       chiropractic examiners, board of dental examiners, board of  
7       examiners in optometry, and board of veterinary examiners.

8       SECTION 2. Sections 26-9, 442-2, 442-3, 442-11, 442-14,  
9       451D-2, and 663-1.8, Hawaii Revised Statutes, are amended by  
10      substituting the term "Hawaii board of chiropractic" wherever  
11      the term "state board of chiropractic examiners", or similar  
12      term, appears, as the context requires.

13      SECTION 3. Sections 26-9, 423-1, 447-1, 447-1.5, 447-2,  
14      447-3, 447-3.5, 447-4, 447-6, 447-7, 448-1.5, 448-2, 448-3,  
15      448-5, 448-7, 448-9.6, 448-11, 448-12, 448-13, 448-16, 448-16.5,  
16      448-22, 448-23, and 451D-2, Hawaii Revised Statutes, are amended  
17      by substituting the term "board of dentistry and dental



1 hygienists" wherever the term "board of dental examiners"  
 2 appears, as the context requires.

3 SECTION 4. Sections 26-9, 424-1, 459-1.5, 459-3, 459-5,  
 4 459-7, 459-9, and 461-15, Hawaii Revised Statutes, are amended  
 5 by substituting the term "Hawaii board of optometry" wherever  
 6 the term "board of examiners in optometry" appears, as the  
 7 context requires.

8 SECTION 5. Sections 26-9, 451D-2, 471-1, 471-2, 471-3,  
 9 471-7, 471-8, 471-9, 471-11, and 471-14, Hawaii Revised  
 10 Statutes, are amended by substituting the term "Hawaii board of  
 11 veterinary medicine" wherever the term "board of veterinary  
 12 examiners" appears, as the context requires.

13 SECTION 6. This Act shall take effect on July 1, 2018;  
 14 provided that the amendments made to section 26-9, Hawaii  
 15 Revised Statutes, in sections 2, 3, 4, and 5 of this Act shall  
 16 not be repealed when section 26-9, Hawaii Revised Statutes, is  
 17 amended by section 5 of Act 181, Session Laws of Hawaii 2017.


