Traffic Violations; Pickup Trucks; Passenger Restrictions

Prohibits an operator of any pickup truck from operating the vehicle with a passenger seated in the bed or load-carrying area of the vehicle unless an emergency exists that threatens the life of the passenger being transported in the bed or load-carrying area of the vehicle or the vehicle is being operated in parades, caravans, or exhibitions that are permitted by law.
