
A BILL FOR AN ACT

RELATING TO PUBLIC SCHOOLS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

SECTION 1. The legislature finds that Act 97, Session Laws of Hawaii 1965, transferred the responsibility for functions that were deemed to be of statewide concern from the counties to the State. Among these functions were the planning, construction, improvement, and maintenance of public school facilities and grounds, and the transportation of school children. Prior to the passage of Act 97, Session Laws of Hawaii 1965, the counties issued bonds to plan, construct, improve, and maintain public school facilities and grounds. Since these functions are now wholly the responsibility of the State, it only makes sense to begin transferring all remaining county lands and improvements under the department of education to the State.

Act 154, Session Laws of Hawaii 2003, conveyed fee simple title of all county of Hawaii lands being used by the department of education to the State. The county of Hawaii was the only



1 county to have legislation passed to convey the fee simple
2 interest in its properties to the State.

3 The State of Hawaii's department of education has invested
4 significant public funds on the maintenance and capital
5 improvement projects for new school facilities. The expenditure
6 of these public funds was done without regard to the underlying
7 fee ownership of the property. If the school is on county land,
8 this investment in vertical improvements is transferred to the
9 county when a school is closed, which is what happened when
10 Wailupe elementary school closed.

11 The legislature further finds that Act 155, Session Laws of
12 Hawaii 2013, provided the department of education with the
13 authority to develop its assets to create twenty-first century
14 schools. Act 155 also allowed the department of education to
15 explore different mechanisms to redevelop its assets, including
16 revenue generation in support of investments in twenty-first
17 century schools.

18 The legislature additionally finds that the department of
19 education is responsible for approximately 2,120
20 acres/92,353,688 square feet of land under its school facilities
21 within the city and county of Honolulu. Of this total land



1 area, the city and county of Honolulu owns approximately one-
2 half of the land under the existing school facilities,
3 approximately one thousand and four acres/43,753,360 square
4 feet.

5 The legislature finds that the split ownership of the
6 underlying fee simple lands under existing schools creates
7 problems for redevelopment, especially when private investment
8 is involved. In order to allow the department of education
9 flexibility to redevelop or reposition its assets, especially
10 along the rail transit corridor, the State of Hawaii should
11 consolidate ownership of the lands under existing public
12 schools.

13 The legislature further finds that, from an asset
14 management standpoint, the department of education should also
15 be given the authority and responsibility to own the real
16 property on which their educational facilities are located.
17 This will allow the department to maximize the value of its real
18 estate assets as it seeks to redevelop and reposition public
19 educational facilities in the future.

20 The purpose of this Act is to:



- 1 (1) Transfer parcels of property containing schools
2 operated by the department of education that are
3 currently owned by the city and county of Honolulu to
4 the State;
- 5 (2) Give the department of education the power to acquire
6 and hold title to real, personal, or mixed property
7 for use for public educational purposes; and
- 8 (3) Require legislative approval prior to the sale or gift
9 of lands to which the department of education holds
10 title.

11 **PART II**

12 SECTION 2. (a) Notwithstanding any other law to the
13 contrary, the fee simple interest to the following parcels of
14 land with the existing improvements thereon (hereinafter "the
15 properties") (but not including submerged land, accreted land,
16 or any land makai of the shoreline), shall be conveyed by the
17 city and county of Honolulu to the department of education as
18 grantee, as is, where is:

7 (b) The city and county of Honolulu shall prepare,
8 execute, and record, in the land court or bureau of conveyances,
9 as appropriate, a quitclaim deed to convey each above-listed
10 parcel with all existing improvements, subject to the property
11 boundaries determined pursuant to subsection (d), to the
12 department of education, as grantee. As these are conveyances
13 in which the city and county of Honolulu and the State and its
14 agencies are the only parties, the tax imposed by section 247-1,
15 Hawaii Revised Statutes, shall not apply to them. Effective on
16 the date of transfer pursuant to subsection (e), every reference
17 to the present titleholder or the head of the department or
18 agency in each instrument, if the titleholder is a department or
19 an agency, shall be construed as a reference to the department
20 of education.



1 (c) The department of education shall accept the
2 properties in their existing condition. All claims and
3 liabilities against the city and county of Honolulu, if any,
4 which the department of education has, may have had, or may have
5 in the future, regarding any injury, loss, cost, damage, or
6 liability, including reasonable attorney's fees, concerning the
7 physical, environmental, soil, economic, and legal conditions of
8 the conveyed properties, are released, waived, and extinguished.

9 (d) Because the tax map numbers for parcels (2), (3), (5),
10 (6), (7), (10), (11), (15), (16), (24), (25), (27), (28), (33),
11 (39), (40), (41), (42), (43), (47), (48), (49), (51), (54),
12 (55), (57), (59), (60), (62), (63), (64), (66), (68), (74),
13 (75), and (84) under subsection (a) include an abutting city and
14 county of Honolulu public park, the department of education and
15 the city and county of Honolulu shall agree on the proposed
16 property boundary separating the school and park portions of the
17 properties. The department of education shall subdivide the
18 foregoing parcels in accordance with the agreed upon property
19 boundaries.

20 (e) Transfer of parcels shall be effective December 31,
21 2019.



1 PART III

2 SECTION 3. Chapter 302A, Hawaii Revised Statutes, is
3 amended by adding a new section to be appropriately designated
4 and to read as follows:

5 "§302A- Public school real property, acquisition, use,
6 and disposition of property. (a) The department may acquire or
7 contract to acquire by grant or purchase any real, personal, or
8 mixed property or any interest therein for its immediate or
9 future use for public educational purposes, including lease
10 revenues; and own, hold, improve, and rehabilitate any real,
11 personal, or mixed property acquired, and sell, assign,
12 exchange, transfer, convey, lease, or otherwise dispose of, or
13 encumber the same.

14 (b) The department may by itself, or in partnership with
15 qualified persons, acquire, construct, reconstruct,
16 rehabilitate, improve, alter, or repair any infrastructure or
17 accessory facilities in connection with any project; and own,
18 hold, sell, assign, transfer, convey, exchange, lease, or
19 otherwise dispose of, or encumber any project.

20 (c) The department may lease or rent all or a portion of
21 any real property acquired for public educational purposes and



1 establish and revise the rents or charges therefor. The
2 department may sell, exchange, transfer, assign, or pledge any
3 property, real or personal, or any interest therein to any
4 government entity.

5 (d) The department may insure or provide for the insurance
6 of its property or operations against risks as it deems
7 advisable.

8 (e) For purpose of this section:

9 "Land" or "property" includes vacant land or land with site
10 improvements, whether partially or entirely finished in
11 accordance with governmental subdivision standards, or with
12 complete dwellings.

13 "Public educational purposes" includes any use of the
14 property, including revenue generation, that would benefit the
15 department's mission to provide public education to students in
16 the State.

17 "Real property" includes lands, land under water,
18 structures, and any and all easements, franchises, and
19 incorporeal hereditaments and every estate and right therein,
20 legal and equitable, including terms for years and liens by way
21 of judgment, mortgage, or otherwise."



SECTION 4. Section 171-2, Hawaii Revised Statutes, is amended to read as follows:

"§171-2 Definition of public lands. "Public lands" means all lands or interest therein in the State classed as government or crown lands previous to August 15, 1895, or acquired or reserved by the government upon or subsequent to that date by purchase, exchange, escheat, or the exercise of the right of eminent domain, or in any other manner; including lands accreted after May 20, 2003, and not otherwise awarded, submerged lands, and lands beneath tidal waters that are suitable for reclamation, together with reclaimed lands that have been given the status of public lands under this chapter, except:

(1) Lands designated in section 203 of the Hawaiian Homes Commission Act, 1920, as amended;

(2) Lands set aside pursuant to law for the use of the United States;

(3) Lands being used for roads and streets;

(4) Lands to which the United States relinquished the absolute fee and ownership under section 91 of the Hawaiian Organic Act prior to the admission of Hawaii as a state of the United States unless subsequently



1 placed under the control of the board of land and
2 natural resources and given the status of public lands
3 in accordance with the state constitution, the
4 Hawaiian Homes Commission Act, 1920, as amended, or
5 other laws;

6 (5) Lands to which the University of Hawaii holds title;

7 (6) Lands to which the Hawaii housing finance and
8 development corporation in its corporate capacity
9 holds title;

10 (7) Lands to which the Hawaii community development
11 authority in its corporate capacity holds title;

12 (8) Lands to which the department of agriculture holds
13 title by way of foreclosure, voluntary surrender, or
14 otherwise, to recover moneys loaned or to recover
15 debts otherwise owed the department under chapter 167;

16 (9) Lands that are set aside by the governor to the Aloha
17 Tower development corporation; lands leased to the
18 Aloha Tower development corporation by any department
19 or agency of the State; or lands to which the Aloha
20 Tower development corporation holds title in its
21 corporate capacity;



(10) Lands that are set aside by the governor to the agribusiness development corporation; lands leased to the agribusiness development corporation by any department or agency of the State; or lands to which the agribusiness development corporation in its corporate capacity holds title; ~~and~~

(11) Lands to which the Hawaii technology development corporation in its corporate capacity holds title; and

(12) Lands to which the department of education holds title;

provided that, except as otherwise limited under federal law and except for state land used as an airport as defined in section 262-1, public lands shall include the air rights over any portion of state land upon which a county mass transit project is developed after July 11, 2005."

SECTION 5. Section 171-64.7, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows:

"(a) This section applies to all lands or interest therein owned or under the control of state departments and agencies classed as government or crown lands previous to August 15, 1895, or acquired or reserved by the government upon or



1 subsequent to that date by purchase, exchange, escheat, or the
2 exercise of the right of eminent domain, or any other manner,
3 including accreted lands not otherwise awarded, submerged lands,
4 and lands beneath tidal waters that are suitable for
5 reclamation, together with reclaimed lands that have been given
6 the status of public lands under this chapter, including:

7 (1) Land set aside pursuant to law for the use of the
8 United States;

9 (2) Land to which the United States relinquished the
10 absolute fee and ownership under section 91 of the
11 Organic Act prior to the admission of Hawaii as a
12 state of the United States;

13 (3) Land to which the University of Hawaii holds title;

14 (4) Land to which the Hawaii housing finance and
15 development corporation in its corporate capacity
16 holds title;

17 (5) Land to which the department of agriculture holds
18 title by way of foreclosure, voluntary surrender, or
19 otherwise, to recover moneys loaned or to recover
20 debts otherwise owed the department under chapter 167;



(6) Land that is set aside by the governor to the Aloha Tower development corporation; or land to which the Aloha Tower development corporation holds title in its corporate capacity;

(7) Land that is set aside by the governor to the agribusiness development corporation; or land to which the agribusiness development corporation in its corporate capacity holds title; [and]

(8) Land to which the Hawaii technology development corporation in its corporate capacity holds title[-];
and

(9) Land to which the department of education holds title."

PART IV

SECTION 6. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2018-2019 as a grant-in-aid to the city and county of Honolulu to prepare, execute, and record the quitclaim deeds required under this Act.

The sum appropriated shall be expended by the city and county of Honolulu for the purposes of this Act.



1 SECTION 7. Statutory material to be repealed is bracketed
2 and stricken. New statutory material is underscored.

3 SECTION 8. This Act shall take effect on July 1, 2018.
