## A BILL FOR AN ACT

RELATING TO CHILD WELFARE SERVICES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that the east Hawaii
2	child welfare services section in the county of Hawaii faces
3	unique challenges as it is the office responsible for the safety
4	and well-being of the State's most vulnerable children who have
5	been abused, neglected, or are at high risk for abuse and
6	neglect. The office oversees the safety of endangered children
7	in a geographic area that extends from Honokaa to Ocean View,
8	including the districts of north and south Hilo, Puna, and much
9	of Hamakua and Kau. Furthermore, the rate of confirmed cases
10	for abuse or neglect in 2015 was two hundred thirteen children
11	per 100,000 residents in Hawaii county, nearly triple the rate
12	of confirmed cases for the city and county of Honolulu.
13	The legislature further finds that due to challenging
14	economic times and funding cuts in Hawaii's child welfare
15	services, layoffs and hiring restrictions have caused the east
16	Hawaii child welfare services section to lose nineteen of the
17	fifty-six positions it had in 2009, resulting in a dramatic

1	increase in average caseload per caseworker. The recommended
2	number of caseloads for social workers is no more than fifteen
3	children, but social workers in east Hawaii regularly have
4	caseloads of forty to fifty children. These higher caseloads
5	increase the potential for harm to children at risk for neglect
6	or abuse, further contributing to the high rate of confirmed
7	cases in Hawaii county, and has even prompted the family court
8	to sanction the east Hawaii child welfare services section
9	because of late filings of reports and failure to meet court
10	deadlines. Therefore, the legislature finds that it is
11	necessary to undertake a pilot project demonstrating the
12	positive impact of adequate staffing levels on the safety and
13	well-being of at-risk children and families in east Hawaii.
14	The purpose of this Act is to appropriate funds for:
15	(1) The department of human services to establish a five-
16	year pilot program in the east Hawaii child welfare
17	services section in Hawaii county that limits the
18	number of children per child welfare services
19	caseworker to no more than twenty; and
20	(2) Additional case managers and support staff for the
21	pilot program.

1	SECTION 2. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$ or so
3	much thereof as may be necessary for fiscal year 2018-2019 for:
4	(1) The department of human services, child welfare
5	services branch, to establish a five-year pilot
6	program that limits the number of children supervised
7	by each child welfare services caseworker at no more
8	than twenty in the east Hawaii child welfare services
9	section in the county of Hawaii; and
10	(2) Eight full-time equivalent (8.0 FTE) case managers and
11	fifteen full-time equivalent (15.0 FTE) support staff
12	positions for the pilot program.
13	The sum appropriated shall be expended by the department of
14	human services for the purposes of this Act.
15	SECTION 3. This Act shall take effect on July 1, 2018.
