A BILL FOR AN ACT

RELATING TO LANGUAGE ACCESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature formerly recognized and
- 2 acknowledged that language is a barrier for those living in
- 3 Hawaii who have identified themselves as being limited in
- 4 English proficiency. Consequently, the legislature passed Act
- 5 90, Session Laws of Hawaii 2006, and amended Act 290 with the
- 6 passage of Act 201, Session Laws of Hawaii 2012, to ensure that
- 7 limited English proficient individuals have meaningful access to
- 8 state-provided and state-funded services in Hawaii. These Acts
- 9 established the Hawaii office of language access to provide
- 10 oversight, central coordination, and technical assistance to
- 11 twenty-six state agencies and more than one hundred state-funded
- 12 agencies in their implementation of the requirements of Hawaii's
- 13 language access law.
- 14 The technical assistance provided to agencies by the office
- 15 of language access include needs assessments, assistance with
- 16 language access plans, training of agency staff, work with
- 17 interpreters and translators, data collection, reporting, and

- 1 more. The office of language access also conducts periodic
- 2 compliance monitoring and provides complaint resolution.
- 3 Furthermore, Act 217, Session Laws of Hawaii 2013, created
- 4 the statewide language access resource center within the office
- 5 of language access. The objectives of the statewide language
- 6 access resource center are laudable but require significant time
- 7 and resources for planning, coordination, and management. The
- 8 current staff of the office of language access have been
- 9 providing their time and expending a tremendous amount of
- 10 resources to get the statewide language access resource center
- 11 off the ground-work that was envisioned to be the responsibility
- 12 of the staff of the statewide language access resource center.
- 13 However, staff for the statewide language access resource center
- 14 have yet to be hired.
- As it currently stands, the office of language access is
- 16 already understaffed and has been operating with only three
- 17 authorized full-time equivalent positions since 2013. As a
- 18 result, the office of language access has not been able to fully
- 19 perform its statutorily mandated compliance and technical
- 20 assistance functions. Accordingly, many state agencies have
- 21 been unable to implement important aspects of their language

- 1 access plans and many individuals limited in English proficiency
- 2 in Hawaii continue to lack meaningful access to government
- 3 services, programs, and activities.
- 4 The purpose of this Act is to establish two permanent full-
- 5 time equivalent positions within the office of language access
- 6 to assist state agencies and state-funded agencies in
- 7 implementing the requirements of Hawaii's language access law.
- 8 SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so much
- 10 thereof as may be necessary for fiscal year 2018-2019 for the
- 11 establishment of two full-time equivalent (2.00 FTE) permanent
- 12 program specialist positions within the office of language
- 13 access to assist state agencies and state-funded agencies in
- 14 implementing the requirements of Hawaii's language access law.
- The sum appropriated shall be expended by the department of
- 16 health for the purposes of this Act.
- 17 SECTION 3. This Act shall take effect on July 1, 2018
