# A BILL FOR AN ACT

---

RELATING TO DRIVER'S LICENSING.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1.   Section 286-104.5, Hawaii Revised Statutes, is  
2 amended by amending subsection (a) to read as follows:

3       "(a)   Notwithstanding section 286-104(7) to the contrary,  
4 every person who submits an application for a driver's license,  
5 provisional driver's license, or instruction permit that  
6 satisfies the requirements of this chapter except for the  
7 applicant's inability or refusal to provide satisfactory proof  
8 of authorized presence in the United States under federal law,  
9 or who voluntarily chooses not to obtain a state civil  
10 identification card that is in compliance with the REAL ID Act  
11 of 2005, shall be issued a limited purpose driver's license, a  
12 limited purpose provisional driver's license, or a limited  
13 purpose instruction permit that is uniquely identified in  
14 compliance with the REAL ID Act of 2005 upon satisfactory proof  
15 to the examiner of drivers of the applicant's identity and  
16 residency in the State.   The examiner of drivers shall accept  
17 various types of documentation for the purpose of establishing



1 the applicant's identity and residency in the State, which may  
2 be established by more than one document. Acceptable  
3 documentation includes:

- 4 (1) A valid, unexpired consular identification document  
5 issued by a consulate from the applicant's country of  
6 citizenship or a valid, unexpired passport from the  
7 applicant's country of citizenship;
- 8 (2) An original birth certificate or other proof of age,  
9 as designated by the examiner of drivers;
- 10 (3) A current home utility bill, lease, or rental  
11 agreement, or deed or title to real property in the  
12 State, as designated by the examiner of drivers;
- 13 (4) A United States Department of Homeland Security Form  
14 I-589, Application for Asylum and for Withholding of  
15 Removal;
- 16 (5) An official school or college transcript that includes  
17 the applicant's date of birth or a foreign school  
18 record that is sealed and includes a photograph of the  
19 applicant at the age the record was issued;
- 20 (6) An official school or college identification card that  
21 includes the applicant's full name and a photograph of



1 the applicant at the time the identification was  
2 issued;

3 (7) A United States Department of Homeland Security Form  
4 I-20 or Form DS-2019;

5 (8) A United States Customs and Immigration Services  
6 Deferred Action for Childhood Arrival Approval Letter;

7 (9) A valid identification card for health benefits;

8 (10) A valid identification card for an assistance or  
9 social services program;

10 (11) A current voter registration card issued by the State;

11 (12) A wage stub issued in the last six months;

12 (13) An income tax return filed in the last two years;

13 (14) A social security card;

14 (15) One of the following documents which, if in a language  
15 other than English, shall be accompanied by a  
16 certified translation or an affidavit of translation  
17 into English:

18 (A) Marriage license or divorce certificate;

19 (B) Foreign federal electoral photo card issued on or  
20 after January 1, 1991;

21 (C) Foreign student identification card; or

1 (D) Foreign driver's license; or  
2 (16) Other proof of Hawaii residency as designated by the  
3 director."

4 SECTION 2. New statutory material is underscored.

5 SECTION 3. This Act shall take effect upon its approval.

Driver License; REAL ID Act; State Civil Identification Card
