A BILL FOR AN ACT

RELATING TO THE REGENTS CANDIDATE ADVISORY COUNCIL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 304A-104.6, Hawaii Revised Statutes, is
2 amended by amending subsections (e) and (f) to read as follows:

3 "(e) The candidate advisory council shall consist of
4 ~~[seven]~~ eight voting members to be appointed without regard to
5 section 26-34 as follows:

6 (1) One member who shall be appointed by the president of
7 the senate;

8 (2) One member who shall be appointed by the speaker of
9 the house of representatives; ~~[and]~~

10 (3) Five members who shall be appointed by the governor~~[-~~
11 A]; and

12 (4) One member of the Association of Emeritus Regents of
13 the University of Hawaii, appointed by the chair of
14 the Association of Emeritus Regents of the University
15 of Hawaii~~[-, shall serve as an ex officio, nonvoting~~
16 ~~member of the candidate advisory council, for a term~~
17 ~~not to exceed two years; provided that the appointment~~



1 ~~shall run concurrently with the term of the appointing~~
2 ~~chair]~~.

3 The president of the senate, speaker of the house of
4 representatives, and governor are encouraged to appoint full-
5 time students of the university, university faculty, university
6 staff, or university alumni to the candidate advisory council;
7 provided that if a full-time student is appointed to the
8 candidate advisory council, the student shall have been enrolled
9 as a full-time student for at least three consecutive semesters
10 and shall serve for a term of two years.

11 (f) ~~[Voting members]~~ Members of the candidate advisory
12 council shall serve for the following terms:

13 (1) Those appointed by the president of the senate and
14 speaker of the house of representatives shall serve
15 for a term of four years; ~~[and]~~

16 (2) Those appointed by the governor shall serve for a term
17 of four years; provided that such appointments shall
18 run concurrently with the term of the appointing
19 governor~~[-]~~; and

20 (3) The member from the Association of Emeritus Regents of
21 the University of Hawaii shall serve for a term not to



exceed two years; provided that the appointment shall
run concurrently with the term of the appointing
chair."

SECTION 2. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored.

SECTION 3. This Act shall take effect upon its approval.
