BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 304A-104.6, Hawaii Revised Statutes, is
2	amended by amending subsections (e) and (f) to read as follows:
3	"(e) The candidate advisory council shall consist of
4	[seven] eight voting members to be appointed without regard to

15	of Hawaii[, shall serve as an ex officio, nonvoting
16	member of the candidate advisory council, for a term
17	not to exceed two years; provided that the appointment
