RELATING TO CONDOMINIUMS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 514B, Hawaii Revised Statutes, is
2	amended b	y adding a new section to part VI to be appropriately
3	designate	d and to read as follows:
4	" <u>§</u> 51	4B- Managing agents; functions. (a) The functions
5	that may	be performed by a managing agent retained for the
6	purpose o	f managing the operation of the property shall include
7	but not b	e limited to the following:
8	<u>(1)</u>	Controlling or disbursing funds of the association;
9	(2)	Preparing budgets or other financial documents for the
10		association;
11	(3)	Assisting in providing notice of or conducting an
12		association meeting;
13	(4)	Ensuring compliance with statutory notice
14		requirements;
15	(5)	Determining amounts due to the association;
16	(6)	Collecting amounts due to the association before the
17		filing of a civil action;

1	(7)	Calculating the votes required for quorum or to
2		approve a proposition or amendment;
3	(8)	Completing all forms related to the management of the
4		association that are prescribed by a state agency
5		pursuant to law or rule;
6	(9)	Drafting association meeting notices and agendas;
7	(10)	Calculating, preparing, and responding to inquiries
8		regarding an assessment or estoppel letter or
9		<pre>certificate;</pre>
10	(11)	Negotiating monetary or performance terms of a
11		contract subject to approval by the association;
12	(12)	Drafting pre-arbitration demands;
13	(13)	Coordinating or performing maintenance of real or
14		personal property and other related routine services
15		involved in the operation of the property; and
16	(14)	Complying with the association's governing documents
17		and bylaws as necessary to perform the functions of a
18		managing agent.
19	(b)	A person shall be exempt from the licensing or
20	registrat	ion requirements under section 514B-132 if the person:

1	(1)	Performs clerical or ministerial functions under the			
2		direct supervision and control of a managing agent			
3		licensed or registered pursuant to section 514B-132;

5	(2)	Performs only maintenance functions of the operation			
6		of the property and does not assist with any functions			
7		enumerated under subsection (a)."
