A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Act 183, Session Laws of Hawaii 2017, created a
- 2 food safety certification costs grant program and the food
- 3 safety certification costs grant program special fund, and it
- 4 provided that the revenues of the special fund "shall consist of
- 5 legislative appropriations and interest thereon." Act 183
- 6 appropriated \$500,000 for fiscal year 2017-2018, but it did not
- 7 specify that these moneys were to be deposited into the special
- 8 fund, nor did it appropriate the moneys out of the special fund.
- 9 The purpose of this Act is to provide that the amount
- 10 appropriated in Act 183, Session Laws of Hawaii 2017, shall be
- 11 deposited into the food safety certification costs grant program
- 12 special fund and that the same amount shall be appropriated out
- 13 of the special fund for fiscal year 2018-2019.
- 14 SECTION 2. Act 183, Session Laws of Hawaii 2017, is
- 15 amended by adding a new section to read as follows:
- 16 "SECTION 2A. There is appropriated out of the food safety
- 17 certification costs grant program special fund the sum of

1	\$500,000 of so much thereof as may be necessary for fiscal year

5	SECTION 3. Act 183, Session Laws of Hawaii 2017, section
6	2, is amended to read as follows:
7	"SECTION 2. There is appropriated out of the general
8	revenues of the State of Hawaii the sum of \$500,000 or so much
9	thereof as may be necessary for fiscal year 2017-2018 [for the
10	food safety certification costs grant program of the department
11	of agriculture.] to be deposited into the food safety
12	certification costs grant program special fund; provided further
13	that the general funds will lapse on June 30, 2019.
14	The sum appropriated shall be expended by the department of
15	agriculture for the purposes of this Act."

Description:

Clarifies that the amount appropriated in Act 183, Session Laws of Hawaii 2017, shall be deposited into the food safety certification costs grant program special fund and that the same amount shall be appropriated out of the special fund for fiscal year 2018-2019.

TITLE:

A BILL FOR AN ACT RELATING TO AGRICULTURE.

PURPOSE:

To provide that the amount appropriated in Act 183, Session Laws of Hawaii (SLH) 2017, shall be deposited into the food safety certification costs grant program special fund and that the same amount shall be appropriated out of the special fund for

fiscal year 2018-2019.

MEANS:

Amend Act 183, SLH 2017.

JUSTIFICATION:

Act 183, SLH 2017, created a food safety certification costs grant program and the food safety certification costs grant program special fund. The purpose of these grants is to assist farmers and ranchers in complying with the federal Food Safety Modernization Act, the United States Food and Drug Administration regulations, and state food safety laws.

Act 183 further appropriated \$500,000 for fiscal year 2017-2018 for this grant program. Although the Act provided that the "revenues of the [special] fund shall consist of legislative appropriations and the interest thereon," it did not specify that the appropriation shall be deposited into the special fund, nor did it appropriate the amount out of the special fund. Currently, the appropriation will lapse on June 30, 2018. The Department of Agriculture requires additional time to complete its adoption of administrative rules, as mandated by Act 183, to establish and implement the grant program, and to begin disbursing grants. This bill shall allow the deposit of Act 183's appropriation into the special fund as well as give the

Department of Agriculture another year to expend the appropriation in the form of grants to Hawaii's farmers and ranchers.

Impact on the public: Will support Hawaii's farmers and ranchers by providing grants to assist them in complying with food safety laws.
