### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 4. Notwithstanding the sums hereinabove stated as
- 2 interest upon judgments against the State, payment of interest
- 3 shall be limited to the period from the date of judgment, if
- 4 applicable, to thirty days after the effective date of this Act,
- 5 as provided in section 662-8, Hawaii Revised Statutes, for those
- 6 cases to which that section applies.
- 7 SECTION 5. All unexpended and unencumbered balances of the
- 8 appropriations made in this Act as of the close of business on
- 9 June 30, 2019, shall lapse.
- 10 SECTION 6. If any provision of this Act, or the
- 11 application thereof to any person or circumstance, is held
- 12 invalid, the invalidity does not affect other provisions or
- 13 applications of the Act that can be given effect without the
- 14 invalid provision or application, and to this end the provisions
- 15 of this Act are severable.
- 16 SECTION 7. This Act shall take effect on July 1, 2030.
