A BILL FOR AN ACT

RELATING TO THE LAW ENFORCEMENT OFFICERS SAFETY ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Chapter 28, Hawaii Revised Statutes, is amended by adding to part I a new section to be appropriately designated and to read as follows:

"§28- Law Enforcement Officers Safety Act, as amended; program. Notwithstanding any provision of the law to the contrary, there is established in the department of the attorney general a program that shall be responsible for issuing credentials to qualified law enforcement officers, pursuant to the federal Law Enforcement Officers Safety Act of 2004 (Public Law 108-277), codified at 18 U.S.C. section 926C, as amended."

SECTION 2. New statutory material is underscored.

SECTION 3. This Act shall take effect upon its approval.

JUSTIFICATION SHEET

DEPARTMENT: Attorney General

TITLE: A BILL FOR AN ACT RELATING TO THE LAW ENFORCEMENT OFFICERS SAFETY ACT.

PURPOSE: To allow the Department of the Attorney General ("department") to establish a program issuing credentials to qualified retired law enforcement officers to carry concealed firearms pursuant to the federal Law Enforcement Officers Safety Act of 2004 (Public Law 108-277), codified at 18 U.S.C. section 926C, as amended (LEOSA).

MEANS: Add a new section to part I of chapter 28, Hawaii Revised Statutes.

JUSTIFICATION: LEOSA was implemented by the federal government in 2004 to allow qualified active and retired law enforcement officers to carry concealed firearms nationwide. LEOSA outlines detailed criteria that a qualified law enforcement officer must meet to be able to carry a concealed firearm pursuant to the Act. LEOSA was amended by the Law Enforcement Officers Safety Act Improvements Act of 2010 (Public Law 111-272) and section 1089 of the National Defense Authorization Act for Fiscal Year 2013 (Public Law 112-239).

In 2008, the Attorney General set up a LEOSA certification program to comply with the Act and enable the department to issue credentials to retired law enforcement officers in Hawaii. The department was concerned about having a uniform statewide program that is well regulated and operated with public safety as a priority. Under the program, retired officers may be LEOSA certified only if they pass standardized firearms qualification testing. In 2014, the department entered into a memorandum of understanding with the four county police

chiefs to acknowledge and recognize the department's LEOSA certification program. Additionally, in 2014 the department adopted interim LEOSA program guidelines under which it currently operates. But there has been ongoing discussion of statutory implementation of this LEOSA program.

Impact on the public: The bill gives the department statutory authority to ensure qualified retired law enforcement officers are properly certified to carry concealed firearms safely and pursuant to LEOSA requirements.

Impact on the department and other agencies: This bill clarifies that the department is the agency responsible for issuing credentials to qualified retired law enforcement officers pursuant to LEOSA.
