A BILL FOR AN ACT

RELATING TO THE PACIFIC INTERNATIONAL SPACE CENTER FOR EXPLORATION SYSTEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Chapter 201, part V, Hawaii Revised Statutes,
3	is amended by adding four new sections to read as follows:
4	" <u>§201-</u> Definitions. As used in this part:
5	"Board of directors" means the board of directors of the
6	Pacific international space center for exploration systems.
7	"Space center" means the Pacific international space center
8	for exploration systems.
9	<u>§201-</u> Hawaii unmanned aerial systems test site advisory
10	board; established. (a) There is established a Hawaii unmanned
11	aerial systems test site advisory board, as a subcommittee of
12	the board of directors, to oversee the planning and operation of
13	the Hawaii unmanned aerial systems test site.
14	(b) The advisory board of directors shall be composed of
15	seven members as follows:

Section 201-79, Hawaii Revised Statutes, is 9 amended to read as follows: 10 "[+] §201-79[+] Powers and duties of the Pacific 11 international space center for exploration systems executive director. In addition to any other powers and duties provided 12 13 in this [subpart,] part, the executive director shall: 14 (1) Oversee, supervise, and direct the planning, 15 evaluation, and coordination of space-related 16 activities, and identify and promote opportunities for 17 expanding and diversifying aerospace-related 18 industries in the State pertaining to the space 19 center; 20 (2) Establish partnerships with corporate, government, and University of Hawaii entities that can promote and 21

1 All employees who occupy civil service positions and whose 2 functions are transferred to the Pacific international space center for exploration systems by this Act shall retain their 3 civil service status, whether permanent or temporary. Employees 4 shall be transferred without loss of salary, seniority (except 5 6 as prescribed by applicable collective bargaining agreements), 7 retention points, prior service credit, any vacation and sick 8 leave credits previously earned, and other rights, benefits, and 9 privileges, in accordance with state personnel laws and this 10 Act; provided that the employees possess the minimum qualifications and public employment requirements for the class 11 12 or position to which transferred or appointed, as applicable; 13 provided further that subsequent changes in status may be made 14 pursuant to applicable civil service and compensation laws. 15 Any employee who, prior to this Act, is exempt from civil service and is transferred as a consequence of this Act may 16

10 service and is transferred as a consequence of this Act may 17 retain the employee's exempt status, but shall not be appointed 18 to a civil service position as a consequence of this Act. An 19 exempt employee who is transferred by this Act shall not suffer 20 any loss of prior service credit, vacation or sick leave credits 21 previously earned, or other employee benefits or privileges as a

1 consequence of this Act; provided that the employees possess 2 legal and public employment requirements for the position to 3 which transferred or appointed, as applicable; provided further that subsequent changes in status may be made pursuant to 4 5 applicable employment and compensation laws. The chairperson of the board of directors of the Pacific international space center 6 7 for exploration systems may prescribe the duties and qualifications of these employees and fix their salaries without 8 9 regard to chapter 76, Hawaii Revised Statutes.

10 SECTION 11. All rules, policies, procedures, quidelines, and other material adopted or developed by the office of 11 aerospace development to implement provisions of the Hawaii 12 Revised Statutes that are reenacted or made applicable to the 13 14 Pacific international space center for exploration systems by this Act shall remain in full force and effect until amended or 15 16 repealed by the Pacific international space center for 17 exploration systems pursuant to chapter 91, Hawaii Revised Statutes. In the interim, every reference to the office of 18 19 aerospace development and aerospace advisory committee in those rules, policies, procedures, guidelines, and other material is 20 21 amended to refer to the Pacific international space center for

exploration systems or the board of directors of the Pacific
international space center for exploration systems, as
appropriate.

SECTION 12. All deeds, leases, contracts, loans, 4 5 agreements, permits, or other documents executed or entered into 6 by or on behalf of the office of aerospace development, pursuant 7 to the provisions of the Hawaii Revised Statutes that are reenacted or made applicable to the Pacific international space 8 9 center for exploration systems by this Act shall remain in full 10 force and effect. Effective July 1, 2018, every reference to 11 the office of aerospace development or the aerospace advisory 12 committee in those deeds, leases, contracts, loans, agreements, permits, or other documents shall be construed as a reference to 13 14 the Pacific international space center for exploration systems 15 or the board of directors of the Pacific international space 16 center for exploration systems, respectively.

SECTION 13. All appropriations, records, equipment, machines, files, supplies, contracts, books, papers, documents, maps, and other personal property heretofore made, used, acquired, or held by the office of aerospace development relating to the functions transferred to the Pacific

international space center for exploration systems shall be 1 2 transferred with the functions to which they relate. 3 SECTION 14. This Act does not affect rights and duties that matured, penalties that were incurred, and proceedings that 4 were begun before its effective date. 5 6 SECTION 15. Statutory material to be repealed is bracketed 7 and stricken. New statutory material is underscored. 8 SECTION 16. This Act shall take effect on July 1, 2018. 9



Report Title:

Pacific International Space Center for Exploration Systems; Office of Aerospace Development; PISCES Special Fund Ceiling

Description:

Amends section 201-76, Hawaii Revised Statutes, to expressly place the Pacific International Space Center for Exploration Systems within the Department of Business, Economic Development, and Tourism. Deletes the executive director of the space center as a member of the board and adds the Chancellor of the University of Hawaii at Hilo. Establishes a ceiling of \$1,000,000 for the Pacific international space center for exploration systems special fund. Repeals the office of aerospace development and transfers all rights, powers, functions, and duties to the Pacific international space center for exploration systems. (SD1)
