Report Title:

Citations; Motor Vehicle Repair Violations; Fines

Description:

Authorizes the issuance of a citation for specific violations of the motor vehicle repair laws and rules by licensees. Sets forth a process for licensees to contest the citation and provides for the assessment of fines for each violation.

DEPARTMENT:

Commerce and Consumer Affairs

TITLE:

A BILL FOR AN ACT RELATING TO CITATIONS FOR MOTOR VEHICLE REPAIR VIOLATIONS.

PURPOSE:

To authorize the issuance of citations to licensees who violate motor vehicle repair laws or rules.

MEANS:

Add a new section to chapter 437B, Hawaii Revised Statutes (HRS).

JUSTIFICATION:

Currently, there is no mechanism to issue citations for licensee conduct that violates chapter 437B, HRS.

This bill authorizes the issuance of citations to motor vehicle repair licensees who fail to comply with certain requirements of the motor vehicle repair laws and rules.

The bill identifies three technical violations that would trigger the issuance of a citation to a motor vehicle repair licensee: (1) failure by a repair dealer to conspicuously display a registration or certification certificate; (2) failure by a repair dealer to conspicuously post required signage containing board contact information; and (3) failure by a mechanic to carry or have readily available for inspection the pocket card issued by the Department of Commerce and Consumer Affairs (Department) indicating proof of registration.

The bill requires personal service of the citation and affords the licensee the opportunity to submit a written request for a hearing to contest the citation within twenty calendar days. The bill also provides that failure to pay any assessed fine within thirty calendar days may subject the licensee to further disciplinary action.

Recent addition of citation authority to other licensing laws have positively impacted RICO's efforts to curb licensing law violations by licensees, to ensure quick compliance, and to more efficiently allocate its resources. The Department believes that the enforcement mechanisms set forth in this bill will significantly enhance its ability to address these categories of violations.

Impact on the public: The public will benefit from quick enforcement against certain violations of the motor vehicle repair licensing laws or rules.

Impact on the department and other agencies:
The bill will improve the Department's
ability to address technical violations of
the motor vehicle repair licensing laws and
rules committed by licensees. No impact
upon other agencies is anticipated.
