A BILL FOR AN ACT

RELATING TO INTELLECTUAL AND DEVELOPMENTAL DISABILITIES MEDICAID WAIVER ADMINISTRATIVE CLAIMING SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The department of health developmental
2	disabilities division is the operating agency for the Hawaii
3	medicaid section 1915(c) Home and Community-Based Services for
4	People with Intellectual and Developmental Disabilities waiver.
5	The department of health operates the waiver pursuant to a
6	memorandum of agreement with the department of human services,
7	which is the state medicaid agency supervising the
8	administration of the waiver. Therefore, the department of
9	health can claim allowable medicaid federal financial
10	participation for the proper and necessary costs incurred by the
11	department in administering the waiver. Administrative claiming
12	has become increasingly important to defray the rising costs to
13	states for administration of medicaid programs. To date, the
14	department of health has conducted minimal administrative
15	claiming, and without a special fund to deposit and use
16	administrative federal financial participation for operating the
17	medicaid section 1915(c) Home and Community-Based Services for

- 1 People with Intellectual and Developmental Disabilities waiver,
- 2 the department will lack a fund to ensure the proper and
- 3 efficient administration of the waiver, and the growing federal
- 4 requirements for community integration, quality and
- 5 accountability.
- 6 The requirements of operating the waiver are specified in
- 7 the State's waiver application approved by the federal Centers
- 8 for Medicare and Medicaid Services. Through the delegated
- 9 functions, the department must assure the health and welfare of
- 10 waiver participants, coordinate services, and ensure the service
- 11 quality. Specific requirements for the operating authority
- 12 include completing initial intake for new waiver applicants,
- 13 completing annual re-determinations of level of care for
- 14 continued eligibility, performing fiscal oversight to ensure
- 15 that waiver enrollment and expenditures are managed against
- 16 federally approved limits, implementing person-centered planning
- 17 processes, developing and monitoring participant individualized
- 18 service plans, pre-authorizing waiver services, managing
- 19 utilization, enrolling qualified providers and provider
- 20 monitoring, establishing a statewide rate methodology,
- 21 developing policies and procedures for operating the waiver
- 22 subject to department of human services approval, and

1	implementing quality assurance and improvement activities for
2	required performance measures. The department is contracting to
3	develop a new information technology system to assist case
4	managers manage information and provide analytics. Many of the
5	activities performed by department staff or contracted entities
6	can be claimed as administrative costs.
7	SECTION 2. Chapter 333F, Hawaii Revised Statutes, is
8	amended by adding a new section to be appropriately designated
9	and to read as follows:
10	"§333F- Intellectual and developmental disabilities
11	Medicaid waiver administrative claiming special fund. (a)
12	There is established in the treasury of the State the
13	intellectual and developmental disabilities medicaid waiver
14	administrative claiming special fund, into which shall be
15	deposited:
16	(1) All revenues from medicaid administrative claiming
17	designated for the department that are allowable for
18	operating the Hawaii section 1915(c) Home and
19	Community-Based Services for People with Intellectual
20	and Developmental Disabilities waiver;
21	(2) Appropriations made by the legislature to the fund;
22	(3) Other grants and gifts made to the fund; and

1	(4)	Any income and capital gains earned by the fund.
2	<u>(b)</u>	Moneys in the intellectual and developmental
3	disabilit	ies medicaid waiver administrative claiming special
4	fund shal	l be used by the department for the following purposes:
5	(1)	Payment for fiscal management services of the Hawaii

8	claiming special fund."
9	SECTION 3. Section 36-27, Hawaii Revised Statutes, is

DEPARTMENT:

TITLE:

A BILL FOR AN ACT RELATING TO INTELLECTUAL AND DEVELOPMENTAL DISABILITIES MEDICAID WAIVER ADMINISTRATIVE CLAIMING SPECIAL FUND.

PURPOSE:

To create the Intellectual and Developmental Disabilities Medicaid Waiver Administrative Claiming Special Fund into which federal moneys may be deposited from Department of Health participation in the waiver program.

MEANS:

Add a new section to chapter 333F, Hawaii Revised Statutes(HRS), and amend sections 36-27, 36-30 and 333F-17.5, HRS.

JUSTIFCATION:

The Hawaii State Department of Health, Developmental Disabilities Division operates the Medicaid section 1915(c) Home and Community-Based Waiver for people with intellectual and developmental disabilities (I/DD) through a memorandum of agreement, with the Hawaii State Department of Human Services MedQuest Division.

The requirements of operating the waiver are specified in the State's waiver application approved by the federal Centers for Medicare and Medicaid Services. The department of health must assure the health and welfare of waiver participants, coordinate services, and ensure service quality. Medicaid administrative claiming is allowed for the proper and efficient administration of the waiver.

Currently, there is limited administrative claiming for waiver operations, and funds that are claimed are deposited in the general fund rather than available for the proper and efficient administration of the waiver as allowed by CMS. A special fund is needed to address the requirements for administering the waiver, modernizing operations and

compliance with new federal requirements including mandates that require sweeping changes to home and community based waiver services and the settings they are provided in.

Impact on the public: Reinvestment of federal reimbursement moneys will enhance waiver program sustainability and improve the quality of services to beneficiaries.

Impact on the department and other agencies:
The department will need to work with the
Department of Human Services to amend the
CMS cost allocation plan including the
submittal of an advanced planning document
for the information technology system.
