BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 329-14, Hawaii Revised Statutes, is 2 amended by amending subsection (f) to read as follows: 3 "(f) Stimulants. Unless specifically excepted or unless 4 listed in another schedule, any material, compound, mixture, or 5 preparation which contains any quantity of the following 6 substances having a stimulant effect on the central nervous 7 system, including its salts, isomers, and salts of isomers: 8 (1) Aminorex; 9 (2) Cathinone; **10** (3) Fenethylline; 11 (4)Methcathinone; 12 (5) N-ethylamphetamine; 13 (6) 4-methylaminorex; 14 N, N-dimethylamphetamine; and (7) 15 (8) Substituted cathinones, any compound, except bupropion 16 or compounds listed under a different schedule, **17** structurally derived from 2-aminopropan-1-one by 18 substitution at the 1-position with either phenyl,

1	naphthyl, or thiophene ring systems, whether or not
2	the compound is further modified in any of the
3	following ways:
4	(A) By substitution in the ring system to any extent
5	with alkyl, alkylenedioxy, alkoxy, haloalkyl,

PURPOSE:

Update chapter 329, Hawaii Revised Statutes (HRS), to make it consistent with amendments in federal controlled substances law as required under section 329-11.

MEANS:

JUSTIFICATION:
